Sylvania Schools Bullying Incident Report

Sylvania Schools has actively integrated the requirements of House Bill 276 regarding harassment, intimidation, and bullying (HIB) into the school environment. Each school has put into practice these policies and procedures along with an educational component to teach and help all students learn about this complex issue. Sylvania Schools will continue to address all aspects of harassment, intimidation and bullying in a forthright manner for the benefit of all students.

Definition of Bullying: Harassment, intimidation, or bullying (HIB) means any intentional written, verbal, graphic, or physical act that a student or group of students exhibit toward another particular student more than once, which behavior both causes mental or physical harm to the other student, and is sufficiently severe, persistent, or pervasive that it creates an intimidating, threatening, or abusive educational environment for the other student.

The following is a summary of reported incidents for the district:

January 2016 – June 2016

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is thirty-two (32) incidents, the junior high schools forty-five (45) and the high schools reported thirty-six (36).

August 2015 – December 2015

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is forty-one (41) incidents, the junior high schools reported thirty-three (33) and the high schools reported thirty-two (32).

January 2015 – June 2015

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is thirty-six (36) incidents, the junior high schools reported twenty-eight (28) and the high schools reported twenty-three (23).

August 2014 – December 2014

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is thirty-six (36) incidents, the junior high schools reported thirty-two (32) and the high schools reported thirty-four (34).

January 2014 – June 2014

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is one thirty-six (36) incidents, the junior high schools reported sixty-seven (67) and the high schools reported twenty-six (26).

August 2013 – December 2013

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is thirty-seven (37) incidents, the junior high schools reported fortynine (49) and the high schools reported thirty-three (33).

January 2013 – June 2013

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is one forty-three (43) incidents, the junior high schools reported sixty-five (65) and the high schools reported twenty-seven (27).

August 2012 – December 2012

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is e fifty-seven (57) incidents, the junior high schools reported seventy-two (72) and the high schools reported thirty-seven (37).

January 2012 – June 2012

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is one hundred-seventeen (117) incidents, the junior high schools reported eighty (80) and the high schools reported twenty four (24).

August 2011 - December 2011

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is fifty (50) incidents, the junior high schools reported one-hundred and twelve (112), and the high schools reported thirty-one (31)

January 2011 – June 2011

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is seventy-two (72) incidents, the junior high schools reported fifty-six (56) incidents, and the high schools reported thirty-eight (38) incidents.

August 2010 - December 2010

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is sixty-nine (69) incidents, the junior high schools reported seventy-two (72) incidents, and the high schools reported forty-eight (48) incidents.

January 2010 – June 2010

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is one hundred and ten (110) incidents, the junior high schools reported forty-one (41) incidents, and the high schools reported twenty-three (23) incidents.

August 2009 – December 2009

The total number of incidents of harassment, intimidation, and bullying as reported by the elementary schools is forty-seven (47) incidents, the junior high schools reported thirty (30) incidents, and the high schools reported thirty-five (35) incidents.

January, 2009 – June, 2009

The total number of incidents of harassment, intimidation and bullying as reported by the elementary schools is eighty-four (84) incidents, the junior high schools reported eighty-one (81) incidents and the high schools reported thirty-six (36) incidents.

August, 2008 – December, 2008

The total number of incidents of harassment, intimidation and bullying as reported by the elementary schools is fifty-seven (57) incidents, the junior high schools reported eighty-five (85) incidents and the high schools reported forty-one (41) incidents.
