The following actions were taken by the Northwest Ohio Educational Service Center Governing Board at their regular meeting held August 27, 2019.

The meeting was called to order at 6:30 pm by President Nona Rupp. All in attendance recited the Pledge of Allegiance.

REPORTS:

- •CFO/TREASURER: Homer Hendricks shared an update on 21st Century grant programs for the 2019-20 school year. NwOESC has six grants active for this school year- Swanton MS, Delta ES, Defiance MS, Patrick Henry ES, Wauseon MS, and Holgate MS. He added NwOESC received a School Psychology Intern Grant to offset the costs of this year's intern. Mr. Hendricks concluded with the OSBA Capital Conference registration is complete with the exception of reserving hotel rooms that cannot be done until early September.
- •DIRECTOR OF SPECIAL EDUCATION: Jill Gilliland provided an update on special education. Regarding early childhood, 500 students were screened during inter-agency screenings last spring. In addition, the NwOESC team screened 70 children in the month of August. NwOESC has roughly 800 students enrolled currently in preschool in the districts we serve. The special education team has done a great job of responding to parent requests for preschool screening in a timely manner. We are investigating options for additional equipment for the IEC playground, and working with two companies to compare options and costs. Thanks to great teamwork among supervisors and Brandi Nafziger, Personnel Coordinator, we have been able to fill the majority of positions for the start of the school year.
- •DIRECTOR OF CURRICULUM, INSTRUCTION, & PROFESSIONAL DEVELOPMENT: Kris Dobbelaere shared August events hosted at the ESC including Administrator's Conference and Fall Staff Meetings. Also shared was the Professional Development brochure and a recap of the PD being offered this school year to educators in Northwest Ohio.
- •DIRECTOR OF TECHNOLOGY: Chad Rex reported that the Northwest Ohio ESC mobile app was publicly launched at our Administrator Conference and Staff Orientation meeting. New technology deployments occurred in several areas of the ESC. At the IEC, staff received new Chromebooks and a classroom was upgraded with a short-throw projector and Smartboard. The Northwest Ohio Opportunity School is operating with new Chromeboxes and monitors. Twenty Chromebooks were deployed to the preschool program's classrooms. Chad also shared that the new PRESIS software is nearing completion. The special education office has begun using the preschool portion of the system and the school-aged system will be released for use in the coming weeks. Lastly, Chad is continuing to work collaboratively with NWOCA and northwest Ohio district technology leaders to maintain and enhance networking and professional growth meetings. The first monthly meeting of the year is on September 27.

- •SUPERINTENDENT'S REPORT: Kerri Gearhart shared the first NwOESC Superintendents' meeting of the year will be held on Tuesday, September 10, 2019. The superintendent group meets monthly to discuss issues common across the region, receive updates from ESC Directors and ODE personnel, and

network with one another. Treasurers are included four times throughout the year (October, January, February, and June) as financial information, school Medicaid, employee benefit plan changes, and billing estimates are reviewed. The first meeting of the NwOESC Business Advisory Council will be held on Tuesday, September 10 in conjunction with the Superintendent meeting. The BAC will continue to have a "Spotlight on Business" presentation, highlighting a regional business. This year, a "Spotlight on Education" presentation will be added as well as more dedicated time for County Economic Development Directors, 4CCC, Northwest State Community College, and STEAM members. NwOESC continues to bring awareness of student loan forgiveness opportunities to our teachers and all employees. Two main federal programs exist for this - the Public Service Loan Forgiveness Program and Teacher Loan Forgiveness Program. An informational flier is available through the NwOESC website. All schools, including NwOESC, must file a School Safety Plan with ODE, review it annually and resubmit it every three years. NwOESC completes this for our main site and our offsite locations that serve students. Additionally schools must conduct Emergency Management Testing annually by December 31 and report on three types of tests over a three-year cycle (tabletop, functional, and full-scale exercises). NwOESC is in year three of this requirement and will be conducting full-scale exercises this year. The security cameras in the main building have been installed and are functional at this time. Work on the PA system is next, as we strive to enhance safety and security in our main office. A similar project at the IEC/Opportunity Center campus is planned and we are waiting on BWC grant approval prior to installation. Ms. Gearhart will be serving as the ESC representative on an ODE Committee related to the Student Wellness and Success funding. The state biennium budget allocates \$675 million over two years for traditional districts, community schools, joint vocational school districts and STEM schools for services and programs to support student wellness and success. Districts are required to plan the use of the funds with at least one of eight community partners. Funds can be used to provide additional mental health services, wraparound services, physical health care services, family engagement and support services, mentoring, before and/or after-school programs and more. School districts will collaborate with local organizations to determine the needs in their communities and use these funds to make the greatest impact for their students. Ms. Gearhart provided a summary of recent beginning of year events:

- On August 2, the Administrators' Conference was held bringing area superintendents, treasurers, principals, and other administrators together to gear up for the year with legal and professional updates. We had excellent attendance (approximately 170), representing 23 member districts.
- The NwOESC facilitated the annual bus and van driver in-service trainings held on August 5 this year at Archbold High School. Nancy Blackwelder presented to over 600 bus and van drivers. Thanks to Ashleigh Repp, Office Coordinator, for organizing along with Allen County ESC and Archbold staff.
- The NwOESC New Staff Orientation was held on August 6, with 37 staff designated as "new". The list includes those who were hired after the start of last school year as well as those brand new to our organization. A review of ESCs, our mission and vision, operational processes, and position responsibilities were included.
- The NwOESC Fall Staff Meeting was held on August 8, with a "Be the Difference 2.0" theme. Approximately 350 staff attended and were treated to a keynote by Diana Patton, provided breakfast or lunch, given pertinent updates, and provided an opportunity to network with their supervisors and coworkers in breakout sessions. A big thank you to the many staff who helped make this day successful!
- •Entered into Executive Session for the purpose of investigation of charges or complaints against a public employee, official, licensee, or student. No action was taken.
- •As all of the business of the evening was complete, the meeting adjourned at 7:19 pm. The next meeting will take place on Tuesday, September 24, 2019 at 6:30 pm at the Northwest Ohio Educational Service Center, 205 Nolan Parkway, Archbold, OH.
