RESOLUTION REQUESTING THE BOARD OF ELECTIONS TO PLACE A LEVY ON THE BALLOT OF AN ADDITIONAL TAX IN EXCESS OF THE TEN MILL LIMITATION FOR GENERAL, ONGOING PERMANENT IMPROVEMENTS

The Board of Education of the Tuscarawas Valley Local School District, Tuscarawas County, Ohio, met in Regular Session on the 9th day of August 2004 at the offices of said Board, Zoarville, Ohio, with the following members present: Susan Kaschak, Richard Gooding, Charles Knaack, Mark Porter, Ed Weaver.

The Treasurer advised the Board that the notice requirement of ORC 121.22 and the implementing rules adopted by the Board pursuant thereto were complied with for the meeting.

Mr. Gooding moved the adoption of the following resolution:

WHEREAS, the County Auditor has certified to this Board that the total current tax valuation of this District is \$176,911,355 and that the dollar amount of revenue that would be generated annually by 2.5 mills is \$430,000, calculated in the manner provided by ORC 5705.03.

THEREFORE, BE IT RESOLVED, by the Board of Education of the Tuscarawas Valley Local School District, Tuscarawas County, Ohio, two-thirds (four affirmative votes) of all members elected thereto concurring that:

Section 1. It is hereby found, determined and declared that the amount of taxes which may be raised by the Tuscarawas Valley Local School District Board of Education within the ten-mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of the District, and that it is necessary to levy an additional tax in excess of the ten mill limitation for the benefit of the Tuscarawas Valley Local School District for the purpose of general, ongoing permanent improvements in accordance with ORC 5705.21, at a rate of two and five tenths (2.5) mills for each one dollar of valuation, which amounts to twenty-five cents (\$0.25) for each one hundred dollars of valuation for a period of five (5) years.

Section 2. The question of an additional tax described in Section 1 beginning with the tax list and duplicate for the year 2004 and with the tax first due in the calendar year 2005, be submitted to the electors of the Tuscarawas Valley Local School District in accordance with ORC 5705.21 at the election to be held at the usual voting place within said Tuscarawas Valley Local School District, on the 2nd day of November, 2004;

Section 3. That the Treasurer is directed to certify immediately a copy of this resolution to the Board of Elections of Tuscarawas County, Ohio, no later than 75 days prior to the election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Section 4. That it is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in these formal actions were in meetings open to the public, in compliance with the law.

Mr. Knaack seconded the Motion and upon roll call, the vote resulted as follows: Mr. Gooding, yes; Mr. Knaack, yes; Mr. Porter, yes; Mr. Weaver, no; Mrs. Kaschak, yes.
