TEMPORARY RESIDENCY FORM APPLICATION FOR ATTENDANCE

According to Ohio's School Attendance Law (O.R.C. 3313.64), a student can only attend school tuition free in the district where his/her, "biological-custodial parent" resides. Residence is defined as:

"(1986) 'Residence,' within the meaning of RC 3313.64, must be a place where important family activity takes place during significant parts of each day: a place where the family eats, sleeps, works, relaxes, plays. It must be a place, in short, which can be called a 'home.' Kenton Bd. Of Edn. V. Day, 30 OMisc2d 25, 30 OBR 289, 506 NE2d 1239 (CP)."

In view of your co-habitation with another resident of the Oregon City School District; and as you have no, "legal residence of your own," Oregon City Schools is required to verify your residency. *This application must be filled out completely and returned along with 2 proofs of residency from both parties.*

NOTE: RESIDENCY IS OFTEN VERIFIED THROUGH THE DISTRICT'S RESIDENCY/REGISTRATION DEPARTMENT IN CONJUNCTION WITH THE LOCAL LAW ENFORCEMENT AGENCY. PROOF OF RESIDENCY MAY BE REQUESTED PERIODICALLY.
