- Participants must be recognized by the presiding officer and will be requested to preface their comments by an announcement of their name, address, and group affiliation, if and when appropriate.
- Each statement made by a participant shall be limited to five (5) minutes duration, unless extended by the presiding officer.
- The portion of the meeting during which the participation of the public is invited shall be limited to thirty (30) minutes, unless extended by a vote of the Board.

(The rate will increase to \$60/day for training less than 3 hours per day, \$125/day for training more than 3 hours per day, effective with terms commencing January 2020 and thereafter as approved by the Board on December 11, 2017.)

**E.** Annual Business Resolutions

The Tuscarawas Valley Local Schools Board of Education approves the following general resolutions for the year 2020, as listed and recommended by the Superintendent and Treasurer:

- 1. Authorize the Treasurer to secure advances from the County Auditor when funds are available and payable to the school district.
- 2. Authorize the Treasurer to invest interim funds at the most productive interest rate whenever interim funds are available.
- 3. Authorize the Treasurer to pay bills within the limits of the appropriation resolution as bills are received and when the merchandise has been received in good condition or services have been performed in an acceptable manner.
- 4. Authorize the Treasurer to make modifications to appropriations and to make fund transfers or advances when necessary. A list of these changes is to be given to the Board at the regular monthly meeting immediately following the transfers or advances.
- 5. Authorize the Treasurer to act as custodian of the district safety deposit box.
- 6. Authorize the Board President and Treasurer to borrow money, if needed.
- Authorize the Superintendent to employ certificated or non-certificated personnel prior to approval by the Board when such employment is required to maintain continuity of the educational program. Employment shall be presented and recommended for Board approval at the next Regular Meeting.
- 8. Authorize the Superintendent to serve as purchasing agent for the school district.
- 9. Authorize the Superintendent to act for the Board on matters pertaining to surplus property procured and federal grants.
- 10. Authorize the Superintendent to approve attendance at professional meetings for all school district personnel.
- 11. Authorize the Superintendent to approve the attendance of all Board of Education members at official meetings within the state.
- 12. Authorize the Superintendent to employ substitute teachers approved by the North Coast Shared Services Alliance and the Stark County Educational Service Center.
- 13. Authorize the Superintendent to employ tutors for home instruction at the current hourly rate who are either on the ECO-ESC substitute list or who are certificated/licensed staff members of our school district.
- 14. Authorize the Treasurer to establish a fee of \$.10 per copy charged to individuals requesting copies of the schedule of meetings, agenda, or notice of individual meetings. [RC 121.22(F)]
- 15. Authorize the Treasurer to reimburse staff for the actual cost incurred for meals (including up to 20% for tip) for trips with overnight stays not to exceed \$50 per day.

- 16. Authorize providing complimentary passes and waiving payment of entrance fees for all district employees (with their staff ID badge), local pastors, and senior citizens to district-sponsored events, concerts, programs, and athletic functions.
- 17. Authorize the Superintendent to serve as Civil Rights Coordinator.
- 18. Authorize the Superintendent to serve as the Board of Education's designee to hear appeals for student suspensions in accordance with the law and Board of Education policy.
- Recognize the following organizations as support groups for the district: TV PTO, TV PATHS, TV Band and Choir Boosters, TV Athletic Boosters, TV Affordable Christmas, TV Backpacks 4Kids (Loving Heart Foundation), Trojan Foundation.
- 20. Recognize OAPSE Chapter #634 and the Tuscarawas Valley Teachers' Association as bargaining agents.
- 21. Designate the Times Reporter as the official newspaper for the school district.
- 22. Designate the Superintendent and the President of the Board of Education as the official spokespersons for the school district.

- B. Adopt a resolution to proclaim January 26-February 1, 2020 Public Education Week:

WHEREAS, traditional public school districts in Ohio serve more than 1.8 million students and employ more than 245,000 Ohioans; and

WHEREAS, all children in Ohio should have access to the highest-quality education possible; and

WHEREAS, Ohio citizens recognize the important role that an effective education plays in preparing all students to be successful adults; and

WHEREAS, quality education is critically important to the economic vitality of the Buckeye State; and

WHEREAS, public education not only helps to diversify our economy, but also enhances the vibrancy of our community; and

WHEREAS, Ohio has many high-quality school administrators, teaching professionals, and support staff who are committed to educating our children; and

WHEREAS, public education is celebrated across the country by millions of students, parents, educators, schools, and organizations to raise awareness of the need for effective public schools;

THEREFORE, We, the Tuscarawas Valley Local Schools Board of Education, do hereby recognize January 26 – February 1, 2020 as PUBLIC EDUCATION WEEK and call this observance to the attention of all Ohioans.

C. Adopt a resolution opposing the State of Ohio EdChoice Scholarship (voucher) program:

WHEREAS, the Ohio legislature has recently made amendments which greatly increase the number and availability of vouchers for students to attend private/parochial schools at public tax expense, and

WHEREAS, such vouchers will be available to numerous families and students who have never attended Tuscarawas Valley Local Schools or any other public schools and for whom state funding has never been provided to Tuscarawas Valley Local Schools or any other public schools, and

WHEREAS, Tuscarawas Valley Local Schools' state funding will be unjustly decreased by the amount of the vouchers provided to such families and students who have not and will not attend public schools and others who transfer to private/parochial schools, and

WHEREAS, private/parochial schools accepting students with public tax vouchers would not be required to accept all students but would be permitted to retain their selective admission policies without enforcement of other laws applicable to public schools, and

WHEREAS, private/parochial school students are not subject to the testing standards required of public school students so that the actual performance of private/parochial schools subsidized with public tax dollars will not be known, relative to equivalent public school evaluation standards, and

WHEREAS, this Board believes that the EdChoice voucher program as it currently exists presents serious constitutional issues regarding the separation of church and state and the funding of religious institutions with public tax dollars, and

WHEREAS, the State of Ohio has the constitutional responsibility to secure a thorough and efficient system of common schools, and

WHEREAS, the EdChoice voucher program will have exactly the opposite effect by providing funding to private/parochial schools at the expense and to the detriment of public schools and their students.

NOW, THEREFORE, BE IT RESOLVED by this Tuscarawas Valley Local School District Board of Education that this Board reaffirms its commitment to free accessible public schools which are adequately and equitably funded to guarantee a comparable education for ALL children and therefore opposes and respectfully requests the repeal of the ill-conceived EdChoice voucher program of the State of Ohio.

BE IT FURTHER RESOLVED that this Board opposes any funding programs, vouchers or otherwise, that have the effect of diverting public tax dollars from public schools to private/parochial schools.

BE IT FURTHER RESOLVED that the Treasurer is hereby authorized and directed to forward copies of this Resolution to all Ohio state legislators, the Superintendent of Public Instruction and Governor of the State of Ohio.
