  - Each statement made by a participant shall be limited to five (5) minutes duration, unless extended by the presiding officer.
  - The portion of the meeting during which the participation of the public is invited shall be limited to thirty (30) minutes, unless extended by a vote of the Board.

WHEREAS, a permanent improvement is defined under R.C. 5705.01(E) as any property, asset or improvement with an estimated life or usefulness of five years or more; and

WHEREAS, the School District is authorized by law to acquire, construct or improve a specific permanent improvement or any class of permanent improvements which could be included in a single bond issue; and

WHEREAS, in its budget for Fiscal Year 2020 (2019-2020) and thereafter the Board will have identified the need for certain permanent improvements (the "Permanent Improvements") for the School District; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Tuscarawas Valley Local School District, Tuscarawas and Stark Counties, Ohio, that:

Section 1. The Board levy an additional three and five-tenths (3.50) mill unvoted permanent improvement levy for Tax Collection Year 2020 to fund the Permanent Improvements. The Board currently has one and five-tenths (1.50) mills within the ten mill limitation levied for permanent improvements. Such levy shall be included in the Tax Budget for Fiscal Year 2021.

Section 2. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
