WHEREAS, the Board of Education does not foresee the need to retain ownership of the Property for school purposes; and

WHEREAS, the Board of Education adopted a resolution on February 15, 2010 declaring the Property abandoned and reverted back to the heirs and assigns of Abbie C. Rees and William F. Rees; and

WHEREAS, the Board of Education desires to rescind said resolution and proceed to sell the Property to the Troy Township Trustees in accordance with O.R.C. §3313.41(C).

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Mapleton Local School District, Ashland, Ohio, that:

<u>Section 1</u>. The Board of Education hereby rescinds the resolution that it previously adopted on February 15, 2010 declaring the Property abandoned and reverted back to the heirs and assigns of Abbie C. Rees and William F. Rees.

<u>Section 2</u>. The Board of Education hereby declares the Property to be surplus which will not be needed for any foreseeable school purpose.

Section 3. The Board of Education hereby authorizes the Superintendent and Treasurer to take all actions necessary to sell the Property to the Troy Township Trustees in accordance with O.R.C. '3313.41(C). The sale price and other terms and conditions of the sale shall be subject to the Board of Education's final approval.

<u>Section 4</u>. It is found and determined that all formal actions of this Board of Education concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board of Education, and that all deliberations of this Board of Education and of any of its committees that resulted in these formal actions were in meetings open to the public and in compliance with the law

Discussion: Mrs. Ragle commented that we have taken the steps necessary to proceed. Mr. Alaimo was permitted to make a statement. He pointed out that when the issue first came about, the board was not permitted to research the heirs as a group; Mr. Alaimo and Mr. Barr (former board member) came across the same person; Mr. Alaimo contacted the heir and then got Mary Jones involved who also contacted the heir and they felt it was settled two years ago.
