### **Erie County Relaunches Suicide Prevention Coalition**

Erie County recently relaunched its Suicide Prevention Coalition under the direction of the Erie County ADAMHS Board. On May 1st, representatives from law enforcement, mental health agencies, schools, HR, businesses, and higher education met to discuss community-based suicide prevention and the coalition's role. The meeting focused on defining the coalition and its purpose in education and advocacy. Cheryl Huss, the coalition chair, presented local loss data and addressed myths about suicide that hinder help-seeking.

Following the initial meeting, a workgroup began developing the coalition's structure and created a mission statement: "To decrease suicide attempts and deaths in Erie County through collaboration, advocacy, education, training, and evaluation." With this relaunch, 82 of Ohio's 88 counties now have an active suicide prevention coalition or subcommittee.

#### **New Innovative Tool Generates Customized**

#### 988 Materials for Ohio Communities

Just ahead of the two-year anniversary of the launch of the 988 Suicide and Crisis Lifeline in Ohio, a new tool has been created to allow anyone throughout the state to design free, customized 988 materials that can be shared within their communities.

Ohio's new OHIO988 Materials Generator makes spreading awareness about the 988 Crisis Lifeline easier than ever. This free tool lets anyone create custom handouts, posters, and social media graphics in minutes. Just answer a few questions to pick your language (English or Spanish), tailor messaging, choose a format (handout, poster, etc.), and add logos or contact info. Ohioans can also access the <u>988 Ohio Toolkit</u>, continually updated with downloadable fact sheets, posters, logos, and social media shareables.

The 988 Suicide and Crisis Lifeline was launched nationwide on July 16, 2022. Ohioans who are experiencing a mental health or addiction crisis and their family members are able to call or text 988 or chat 988Lifeline.org to reach a trained call specialist who can offer help and support. # **Upcoming Webinar for OSPF Members**

The presentation will introduce the Employee Benefits Security Administration by describing its mission, structure, what they do, and how it can support behavioral health providers, advocates, and families navigating behavioral health insurance benefits. The presenters will explain that the law they enforce, the Employee Retirement Income Security Act, was amended by the Mental Health Parity and Addiction Equity Act (MHPAEA). The presenters will provide a brief background on and general requirements of MHPAEA, focusing on non-quantitative treatment limitations. The presenters will explain specific areas of focus in MHPAEA enforcement work. The presentation will also describe how to contact their agency with questions or concerns if a patient or family member has been denied treatment or care through insurance benefits.


