
### ROSSFORD EXEMPTED VILLAGE SCHOOLS

Level 1 Public Emergency: active exposure and spread.

Level 3 Public Emergency: very high exposure and spread. Limit activities as much as possible.

Red

Level 4 Public Emergency: severe exposure and spread. Only leave home for supplies and services.

For All Public Emergency Levels, Follow All Current Health Orders

## **Contact Tracing**

- Isolation
- Self-quarantine
- Exposure
- Expanded assigned seating policy
- We will be in communication with the county health department

## **Definition of Terms**

- Contact Tracing tracking those individuals who may have been exposed to the virus
- Isolation used to separate people with confirmed COVID-19 cases from healthy people
- Self-quarantine action taken to separate an individual who has been exposed to someone with the virus
- Exposure within 6 feet for a period longer than
   15 minutes

## **Best Practices**

- Mask requirement for all staff and students
- All common spaces and classrooms (mask use maximized in classroom as determined by instructor)
- Vigilant assessment of symptoms, including daily temperature checks, requirements that students and staff who are sick stay home, and development of a testing protocol with local health authorities \*
- Frequent handwashing, as well as provision of hand sanitizer in high traffic areas \*
- Thorough cleaning of schools to prevent spread of the virus via common surfaces \*
- Social distancing, with a goal of maintaining at least 6 feet between people as often as possible in all areas \*
- Mask use, including development of face covering policy by every district and a general mandate that school staff wear masks \*
- Isolation rooms at both campuses
- Students report directly to the classroom at the start of the day
- Staggered dismissal at the end of the day



## **Family Safety Pledge**

#### District Health and Safety Guidelines and the Family Pledge

#### Dear Families.

The health and safety of our students and staff is very important. Throughout the summer, we have been working diligently with administration, staff, and public health officials to review and develop guidelines related to the Coronavirus (COVID-19).

As we transition back to school, we are asking for your help in keeping our buildings "COVID-19 Free" by following our district's guidelines, pledging to report your child's illness, and keeping students at home when necessary.

The Centers for Disease and Control and Prevention ("CDC") indicates you may have COVID-19 if you have:

- · Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fats
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

Our best defense against viruses is avoiding transmission. By following the recommendations of the CDC and the health department, we can reduce illness in our schools. We are asking for <u>your commitment</u> along with all parents'guardians and staff to:

- Keep sick children home. If your child has symptoms listed above or a fever of 100 degrees or higher, seek
  appropriate medical attention and keep students home until they are symptom-free, fever-free or have been cleared
  by a physician. By delivering your child to school or placing your child on the school bus, you are assuring
  the district and other parents that your child is not ill and is fever-free.
- Report absences. Report your child's absence and share possible COVID-19 symptom information with our attendance secretary or school nurse, so we can track possible case numbers.
- Remind children of the following important health habits:
  - Wash hands. Practice good hand hygiene by washing your hands often with soap and water for at least 20 seconds.
  - Masks are required consistent with school district and health department guidelines.
  - Do not share personal items pens, pencils, cell phones, electronic devices, laptops, water bottles, drinks, food, or unwashed utensils.
  - Avoid close contact with people who are sick. If your child has had close contact with a person with COVID-19, keep your child at home.
  - · Avoid touching your eyes, nose, and mouth whenever possible.
  - · Abide by the district's physical distancing procedures.

Without question, students returning to school buildings includes risks of contracting COVID-19. Those risks are very serious, particularly for persons at higher risk for severe illness from COVID-19. Even with everyone following district guidelines and all cleaning efforts, risks remain. We take our responsibilities to students very seriously, and we will continue to monitor COVID-19 with health officials, implement revised safety protocols as needed, and provide updates to our families.

Rossford Virtual Academy will be offered as a **completely online** option for all students. Parents who elect to choose this option for their child(ren) understand that this is a yearlong commitment, with an option to shift to the traditional setting only available between first and second semesters. Rossford will be **contracting with NOVA** (<a href="https://www.abc-nova.org/parentsstudents.aspx">https://www.abc-nova.org/parentsstudents.aspx</a>) to provide students with high-quality online learning in a completely virtual environment. The NOVA curriculum is self-paced. Students who elect to participate in RVA will not report to campus and will not be assigned to a traditional class/teacher/schedule. It is 100% online.

## **Scheduling Arrangements**

### Elementary

- Dedicated play zones at recess and equipment sanitation at the elementary
- Art, music, PE, and STEM (to occur quarterly)
- Students will remain in homeroom classrooms (limiting number of classroom changes)

### Secondary

- 4x4 schedule developed to reduce number of class changes throughout the day
- Band and choir may have special restrictions and scheduling arrangements

#### **Toledo Area Schools Shared** Safe Return to School Compact

The following are shared general practices agreed to by the Lucas and Wood County Health Departments and the school districts listed. These practices will guide each district as they move forward with a safe re-opening of schools. Each practice is subject to change based on the current area Health Department data. All districts anticipate sudden and unanticipated closings throughout the year. Families are advised to have a back-up plan ready upon short notice.

#### Transportation

Districts will reduce the number of students on the bus to below occupancy limits

- · Students will have assigned seats
- · Masks will be required
- · Where practical, siblings/family members will be seated together

#### Entering School

Temperature checks for students and staff will be required either by family agreement or will be monitored at school.

· Families and Staff will be asked to complete a Family Safety Pledge

#### Wearing Masks at School

- · Students and staff will be required to wear a mask. Conditions and frequency will be guided by the most current county health department and district data
- · Each district will determine where and when masks will be required

#### **Food Service**

All districts will serve healthy meals that are federally compliant.

- · Meal times, menus, and locations may be adjusted to reduce congregating
- · No outside restaurant or food deliveries will be permitted

The school year will begin with a "No Guests or Visitors" rule. Exceptions may be made for essential business.

- · Any visitors with essential business must wear a mask and have their temperature taken
- · Visitors will also sign in and complete the COVID Checklist

#### Social Distancing

Districts acknowledge that even with the best safety protocols, students will incur some level of risk. Districts will increase cleaning and encourage hygiene protocols.

- · Schools plan to welcome all students back for a safe return. All districts will also offer a
- · Districts will strive to maintain six feet of social distancing in classrooms based on The American Academy of Pediatrics recommendations
- · Bell schedules may be adjusted to reduce traffic in hallways and at entrances and exits
- · Band, Choir, Theatre, and Orchestra may have special restrictions

#### Cleaning and Hand Hygiene

CDC Protocols for cleaning will be followed and each school district will work closely with their local Health Department to promote safe practices.

- · Increased cleaning of high-touch surfaces
- · Hand Sanitizing and Hand Washing will be practiced and reinforced
- · Opportunities for increased hand-sanitizing will be provided

#### Meetings, Open Houses, and Conferences

Districts will make reasonable efforts to hold meetings and conferences virtually.

- · Check your district website for information on how Open Houses and meetings will be held
- · Any face to face meetings will require masks and social distancing of six feet

#### Field Trips

Field trips are canceled.

· Districts will revisit this decision mid-year

#### Recess

Reasonable efforts will be made to maintain safe outdoor activities.

· All districts plan to continue recess but may modify schedules and activities

#### Shared Materials and Equipment

Shared computers or equipment will be disinfected between student use.

#### Staff and Student Safety Orientation

All districts will teach, remind and encourage practices that promote a safe return to
