





## Which grade(s) will your children be starting in the 2020 – 2021 school year?




## Which school or schools does your child(ren) attend?



# Which three factors most influence how you feel about your child(ren) attending school in the fall?




- My student's academic growth

#### If students return to school in-person in the fall, please rate your opinion.




I would prefer in-person learning for my child.

I would possibly consider in-person learning depending on what safety measures are able to be implemented.


No, I would not consider in-person learning at all and would only consider virtual learning options.

## Please rate your feelings regarding transportation in the fall.




- My student(s) will use the bus to get to school.

If, because of social distancing and safety guidelines, we must limit the number of students in our schools which option would you prefer?




- Every other week: one week in school alternating with one week of virtual learning at home
- Even/Odd Calendar Days: half the students come to school on EVEN days and half on ODD (all students continue virtual learning when not in school)
- Monday/Tuesday or Thursday/Friday: Students would be divided into two groups and assigned to be in-school on those days, with virtual learning for all on Wednesdays and when not in school
- K-6 attends school in person; 7th-12th starts school online

The CDC has made several recommendations for schools to consider when reopening. Which (if any) of these recommendations would you be concerned about negatively affecting your child if required by the school district?




- Wearing a cloth or disposable mask
- Maintaining social distance (sitting at least 6 feet apart in class)
- Limited groups in communal spaces
- Restricted use of communal supplies
- Eating breakfast/lunch in classrooms to limit group size
- Having temperature checked daily upon entering the building
- Requirement to stay home if any cold or flu like symptoms occur
- Washing or sanitizing hands at least once every 2 hours
- Use of water bottle versus water fountain


Are you considering enrolling your child in a cyber charter school next fall (not associated with AASD)?
