

Coronavirus Aid, Relief and Economic Security Act (CARES)

Madison Adult Career Center (MACC) signed and returned the Certification and Agreement to the Department of Education to provide emergency financial aid grants to students for expenses related to the disruption of campus operations due to the coronavirus pandemic.

MACC has been allocated a total of \$110,102 and assures that no less than 50 percent (\$55,051) of the funds received under Section 18004(a)(1) of the CARES Act will be used to provide Emergency Financial Aid Grants to students.

The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

MACC determined the following groups of students would be eligible to receive funds from the CARES Act:

- Students who were actively enrolled in a Career Development programs during spring or summer of 2020.
- Students who were deemed eligible to receive Title IV funding.
- MACC identified 71 students to be eligible for Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

MACC initially created a formula based on the number of hours a student is/was enrolled in the 2019-2020 school year and remained enrolled during the period of time 3/17/2020 – 6/30/20 (later extended to 9/30/2020). MACC initially allocated 85% of the \$55,051 available funds to this formula, with each student receiving a minimum Grant of \$150. Seventy one students received a total of \$46,902.00. After 6/30/20 three more students were identified as eligible and an additional \$2,508.00 was disbursed to students. As of September 30, 2020, the total expenditure of \$49,410 was disbursed to students who were deemed eligible.

The remaining funds of \$5,641 were disbursed to students who completed an application and demonstrated additional need for Emergency Financial Aid Grants for expenses incurred related to the disruption of campus operation due to the coronavirus pandemic. Expenses included food, housing, course materials, technology, health care and child care. Applications were due by August 28th. Applications were received and evaluated individually. Eight students were disbursed Emergency Funds ranging from \$500 to \$5,000.

As of September 30, 2020, the total expenditure of \$55,051 was disbursed to students who were deemed eligible.
