### OFFICIAL TIME FRAME FOR TWO (2) POSITIONS TO SERVE FOUR (4) YEAR TERMS

#### LITTLE WOUND SCHOOL SERVICE AREA POLLING SITES OPEN FROM 7:00 AM – 7:00 PM

MEDICINE ROOT DISTRICT (Kyle), PASS CREEK DISTRICT (Allen), WAKPAMNI DISTRICT (Batesland and Wakpamni Lake Community), PORCUPINE DISTRICT (Porcupine and Sharps Corner), WOUNDED KNEE DISTRICT (Manderson and Wounded Knee), EAGLE NEST DISTRICT (Wanblee), LACREEK DISTRICT (Martin)

*Petitioners must pick up and return their own petition. Petitioners are required to pay for their own background checks. A \$40.00 money order, for federal and state background check must be taken to Little Wound School Business Office (LWS Human Resources will process). A \$20.00 money order must be taken to OST Pine Ridge Court House for Tribal background check.*

*The School also requires a drug test to be done by each Petitioner, a \$35.00 money order will need to be taken to the LWS Business Office and drug test completed onsite by one of the school nurses.*
