#### **PRESENTATIONS**

ERIE COUNTY DEPARTMENT OF JOB & FAMILY SERVICES — Ashley Gilbert spoke to the Boar regarding an 18 year old client that Tracie McVeigh has whom is currently in agency custod Client is currently not eligible for emancipation due to graduating high school yet and havir challenges such as being deaf and having mental and cognitive health issues. Client is from anoth country and was supposed to be adopted but the adoption was never finalized, once it became to much for client's adoptive mother to handle, she turned her over to Child Services a year in a ha ago. The client is now in a residential facility and requires 24-hour supervision. Cost is near \$1,300 a day to be housed at this facility, in 2024 the client was considered Title IV-E reimbursab which is generally up to 50% of the eligible costs associated with children in foster care. Now the she is 18 years old she has lost this Title IV-E reimbursement. Lisa informed Ashley that the schooling is responsible to take on boarding cost for client until they are 22 years old. The Boar has asked for Job and Family Services to follow up with the school regarding this and then follow up with the Board.

**FY 26 BUDGET RECOMMENDATION** – Diane informed the Board of the FY26 recommendations the were received and what we have recommended (See attachment). She has recommended we take les levy dollars by leaving \$1 million levy dollars on the table, Finance committee has approved of thes changes. Federal Block grants were cut, about \$75,000 was cut for the FY26. The Chair asked fo motion, motioned by Rob Quinn and seconded by Lisa Crescimano. The motion passed.

**REGIONAL AND STATE UPDATES** – Diane let the Board know as of now we are unsure how muc federal dollars we will be getting for FY26. Behavioral Health funding is set to decrease and there wil be no Crisis dollars next year. Diane and Caleb are working on a strategic plan by hosting communit forums and categorizing it by the top 3 needs in Erie County.

**CORSA INSURANCE COVERAGE 2025-26** – Diane told the Board that the cost will remain the same and we will still have the same amount of coverage and must pay the annual fee. The Chair asked fo motion, motioned by Lisa Crescimano and seconded by Thomas Tucker. The motion passed.
