

# School Safety and Security Information August 15, 2023

### Safety Planning, Supports, and Training

**Building Safety Plans** – Every three years the buildings update their safety plans. The appropriate police and fire departments sign off on these plans. They are then reviewed and approved by the Ohio School Safety Center.



**Safety Meetings** – Twice a year the School Safety Committee and administrative team meet with the local police and fire departments to discuss school safety issues.

School Resource Officers – At the start of the 2023-24 school-year, the district has two full-time School Resource Officers. One from Bellbrook City, which services Stephen Bell Elementary and Bell Creek Intermediate, and one from Sugarcreek Township ,which services Bellbrook High and Middle School. An additional officer from the Sugarcreek Township Police Department is slated to be added in the fall of 2023. One STPD Officer will be at both BMS and BHS.

Active Shooter Response Team – The Board passed a resolution on September 8, 2022, to authorize the creation of an Active Shooter Response Team Implementation Committee and the creation of a highly-vetted and highly-trained volunteer Active Shooter Response Team. The Board passed resolutions on May 11, and August 10, 2023 to appoint certain individuals as members of Active Shooter Response Team.

**County-Wide Response to Active Shooter/Active Threat Situation** – Greene County created this plan with input from each of the police departments and school districts in the county. Representatives from the groups meet twice a year to discuss.

**ALICE Training** – All staff members are trained in ALICE (Alert, Lockdown, Inform, Counter, Evacuate). The district has three certified trainers on staff. All students in grades 6 to 12 watch a video on ALICE. Elementary classrooms have age-appropriate story books on emergency preparedness. All schools complete periodic training, discussion and preparation for active shooter situations at least once per school year.

**Threat Assessment Teams** – Each building has a trained threat assessment team that analyzes threatening behaviors and/or situations at school.

**Crisis Prevention Institute** – Many staff members, administrators and bus drivers are trained annually on CPI. This is nonviolent crisis intervention training designed to teach best practices for de-escalation and managing difficult situations and disruptive behaviors.

**Stop the Bleed training** – This training prepares participants to recognize life-threatening bleeding and intervene effectively.

## **Student Supports**

Counselors and Mental Health Counselor – We have increased our days of mental health counselors by two days per week for a total of six. Our counselors and mental health therapists work hand-in-hand with our parents, students, and staff and provide as much support as possibe. If a higher level of support is necessary, then we do our best to direct them to additional and/or more intensive resources.



Hope Squad (BMS) – Hope Squad's mission is "... to prevent suicide through public awareness and eduction, reduce stigma, and serve as a resource to those touched by suicide." Students, staff and parents are trained in proactive/preventative measures to

assist their peers in crisis. In addition to suicide interventions, training includes a variety of mental health issues like preventing bullying, reducing stigmas, resilience and self-care. <a href="https://hopesquad.com/mission-history/">https://hopesquad.com/mission-history/</a>

**Handle With Care** – When an event occurs involving one of our students in the community and the local police, school personnel are notified. The Handle With Care program directly addresses the goal of mitigating these negative impacts of exposure to adverse experiences by providing support and on-site, trauma-focused interventions by school staff and/or mental health providers, if necessary, to children identified by local first responders and school personnel.

## **Technology Monitoring, Reporting, and Communication**

**Tip Line** – We use the Ohio School Safety Center tip line. Calls or texts to 844-SaferOH are answered by analysts within Ohio Homeland Security. If action is needed, the school district



and/or proper authorities are notified. Information is on our website, posters are in the buildings and each student will be given a bookmark on the first day of school.

**Securly** – The district uses software that monitors students' internet searches and keystrokes on district accounts and devices. Alerts from Securly analysts are sent to administrators if there are certain alerts such as suicide, threats, etc. There is also a parent app to monitor their child.

**Visitor Management System** – A new system was implemented at the start of the 2022-23 school-year to screen visitors during school hours.

**Radios** – All administrators have radios with a secure channel for communication during an emergency.

#### **Facilities**

**Camera systems** – Each building has interior and exterior security camerasthat were updated at the start of the 2022-23 school-year.

Interior School Doors – These can be quickly shut, locked and secured.

**Outside School Doors** – Doors are locked during the school day. Current access control systems were updated at the start of the 2022-23 school-year.

**3M Impact Resistance Film** – This protectant is installed on windows to slow entry into the buildings.

**Nightlock Security Door Stopper** – These safety barricades have been installed on all classroom doors and other interior doors.



## **Background Checks**

**School Employees** – All employees have BCI/FBI background checks

**Volunteers** – All volunteers are required to get background checks

**State School Safety Grant** – In August 2022, the district was awarded \$200,000 from the School Safety Grant Program, authorized from House Bill 687. That money is being used on the aforementioned updates.
