## FAQs

**Q: My student is currently enrolled at BSS and was just diagnosed with a condition. Who should I contact to learn if they qualify for special services?**

**A:** Please contact the School Psychologist at your child’s school to gather more information about how to proceed.

**Q: If my student can’t keep up with their peers because of a disability or medical condition, will they be retained in their current grade?**

**A:** If a student is not making adequate progress, the Individualized Education Program (IEP) team will convene to discuss potential interventions or next steps for the student.

**Q: Can I bring outside support to an IEP meeting? Does the school provide any support?**

**A:** Yes, per the IEP invitation, you may bring outside support. The school district also offers a parent mentor, Mrs. Ann Maguire. Mrs. Maguire can be reached via email: [parentmentor.annmaguire@gmail.com](mailto:parentmentor.annmaguire@gmail.com), or phone: 937-559-4029.

**Q: How do I know what types of services should be provided by the school and which should be provided by outside doctors/therapists/tutors?**

**A:** This will be determined through the Evaluation Team Report (ETR) and an explanation will be provided by the School Psychologist once the report becomes available.

**Q: How is a student's Least Restrictive Environment LRE determined and what LRE options are available?**

**A:** The LRE is based on the student’s level of need and will be determined by the IEP team based on relevant data and student needs. Placement could include, but is not limited to, the general co-taught and/or special education classrooms, or home instruction.

**Q: What is the difference between a 504 and an IEP?**

**A:** IEPs, under the Individuals with Disabilities Education Act (IDEA), cover students who qualify for Special Education. Section 504 covers students who don't meet the criteria for special education, but who still require some accommodations.
