Dr. Beth Knott, Finance Chair, opened the meeting at 6:06 p.m.

Ms. Spivey Ayers reviewed items included in the Consent Agenda for tonight's Board Meeting. Maira Cortes will be the new Data Manager/Treasurer for Teachey Elementary. An updated list of School Treasurers as well as a new bank signature card for Teachey is included.

Ms. Spivey Ayers discussed the federal allotments previously under review equal to \$430,000 for Asheboro City Schools have been released.

Ms. Spivey Ayers reviewed the 2025-2026 Consolidated Federal Funding Application details. The Consolidated Application includes Title I, II, III and IV federal funds. A summary of how these grant funds are used is included in the Consent Agenda.

Ms. Spivey Ayers discussed the State Budget and concerns over losing Low Wealth funding for 2025-2026. The district is taking a conservative approach by asking each department and each school to cut expenses in supplies by 10%. The State has passed a mini budget bill; SL-2025-89. This bill approves a step increase for years of experience for all staff paid on a state-certified salary scale. The retirement

contribution rate is 24.67% for 2025-2026; this is a 3% increase over 2024-2025. Health insurance premiums are \$8,500 per employee; this is a 5% increase over 2024-2025.

Ms. Spivey Ayers expressed gratitude for the County Commissioners and their continued support of our financial needs. The County Commissioners provided an increase of \$550,000 in Local Current Expense Appropriation for 2025-2026. This increase will help cover the anticipated increase of \$330,000 in salary and benefit expenses as well as cover the \$220,000 recurring costs that were previously covered by the terminated TSL grant funds.

There being no further business, Dr. Beth Knott, Finance Chair, adjourned the meeting at 6:29 p.m.

Superintendent's Report

Dr. Woody shared the following:

- Today, we officially welcomed teachers back for their first workday of the year. The energy and
 vibrance in our classrooms and hallways were unmistakable. Many of our teachers and staff
 have been actively engaged throughout the summer, leading camps, hosting student activities,
 and supporting school projects. Across the district, you'll notice freshly waxed floors, updated
 media centers and classrooms, fresh paint, and fresh mulch on our campuses as we prepare to
 welcome families.
- We have updated signage in this building and at our Innovation Center. Several new spaces are nearing completion, and Mrs. Brady will share more details about those later this evening.

- This year, we have set ambitious goals with targeted expectations for improvement. In the months ahead, Dr. Woody will be discussing strategic plan updates and revisions with you as a Board and with our community. Last week, State Superintendent Green presented his newly approved strategic plan. The plan's vision "Achieving Educational Excellence" centers on three core components: High Academic Achievement, Character Development, and making North Carolina public schools the best in the nation. We will be reviewing this plan closely in the coming weeks and completing a crosswalk with our own strategic plan to reflect on alignment.
- Budget & Operations We continue to maintain strong internal controls to monitor budgets at both the
 district and school levels. This year, we have faced budget cuts, particularly in federal grant funding, and
 our state low-wealth dollars and have made strategic adjustments. These include collapsing certain
 positions, requesting a 10% reduction in departmental and school budgets, and evaluating vacancies to
 determine whether roles should be collapsed, combined, or redistributed. Our goal is to maintain highquality programs while remaining transparent and fiscally responsible.
- Looking Ahead This summer has been one of strong planning, strategic thinking, and collaboration.
 Our theme for this school year "Elevate to Excellence" reminds us that achieving our vision will require commitment, effort, and a shared mindset. The stakes are high, and our students are counting on us to provide every opportunity for them to reach their full potential.

Dr. Woody shared we will have a retirement celebration for Ms. Carla Freemyer, Chief of Human Resources & Support Services Officer tomorrow from 3:30-5:30 p.m. in the Professional Development Center.

- **B.** Ms. Brady, Innovation Lead Teacher, along with Global Innovation Center (GIC), interns Leonardo Acosta, and Jayden Hernandez, shared an update about exciting things happening at the GIC, which included the following information:
 - We were able to hire six summer student interns from Asheboro High School through a grant from the NC Business Committee for Education.
 - The interns worked a combined 835 hours over the summer. They helped with summer camps, worked in the labs (assembling/setting up furniture, etc.) and worked with the IT department assisting with preparing devices for the school year.
 - Ms. Brady shared the progress of the following spaces at the GIC: Advanced Modeling Lab, Robotics Lab, Content Creation Studio, SparkNC Learning Lab, Design Thinking Lab, ZSpace Lab, Esports Lab, and the Welcome Center.
 - Summer Fun & Exploration Event showcased the GIC. We welcomed families in the community to see our different labs and the Welcome Center.
 - Esports Bootcamps were held between July 8-Augst 13. These included SparkNC Unit Completion, Rocket League tournament, Roblox coding, and Minecraft challenges.
 - Freedom School, sponsored by Communities in Schools, brought students to the GIC to visit and participate in the various labs.
 - GIC Vision: To empower students with the knowledge and skills necessary to excel in the 21st century.
