 Proof of residency at current address (within the past 2 months) in the custodial
parent's name and address. Acceptable documents are:
A service/utility bill (gas, electric, rent receipt, cable, trash, telephone or water
bill). A voter registration confirmation card is also acceptable. No other "proof"
is acceptable to meet this requirement. Applicants must have an established
residence with proof by way of one of the documents listed above.
 Custody papers, if applicable.
 Current IEP (Individual Education Plan) if the student is receiving special
education services.
 Current ETR (Evaluation Team Report) if the student is receiving special
education services.
