A service/utility bill (gas, electric, rent receipt, cable, trash, telephone or water bill). A voter registration confirmation card is also acceptable. No other "proof" is acceptable to meet this requirement. Applicants must have an established residence with proof by way of one of the documents listed above.
- _____ Custody papers, if applicable.
- _____ Current IEP (Individual Education Plan) if the student is receiving special education services.
