PUBLIC NOTICE

Ohio Revised Code 3734.56(A) requires each Solid Waste Management District in Ohio to write and follow a Solid Waste Management Plan. The purpose of the Plan is to assure that the District has sufficient waste disposal capacity and waste reduction and recycling opportunities for its residents and businesses. The first Erie County Plan became effective January 1, 1994 upon approval by the Director of the Ohio EPA. Ohio Revised Code requires the Plan to be updated every 5 years.

The Erie County Solid Waste Management District Policy Committee has completed a Draft Plan update and established a public comment period beginning Friday, April 1, 2016 and ending Friday, May 6, 2016, when the Draft Plan may be reviewed by the public and written comments submitted. - Authorization for the District Board of Directors to designate facilities for the disposal of District generated solid waste in accordance with Ohio Revised Code Section 343.014.
- Estimated revenues and expenditures from 2016-2031.
- Outreach and Marketing Plan.
