- 1. Are there any changes to your Business Advisory Councils' structure or leadership since you submitted your plan for this academic year?

 Yes. Due to a restructure and reassessment being done within the Auglaize-Mercer Business Education (AMBE) Alliance, their organization has shifted to more of a supportive versus leadership role. The Mercer County ESC, Mercer County Economic Development Office and Wright State University-Lake Campus provide key leadership and coordination.

Developing Professional Skills for Future Careers

Initiative 1 Create awareness of the Business Advisory Council and its resources and events by expanding existing business ↔ student connections.

(9/10) **Planning an In-Demand Career Learning Lab for this Spring, which will be a smaller, targeted, and hands-on event. **Hosted more than 635 middle school students from 6 schools over 3 days for Manufacturing Month in October 2023, and will be hosting a 7th school in April 2024. **Participated in Fall Tri Star Career Fair and currently promoting the Spring event. **Actively adding partners and building relationships to benefit student needs as requested (such as new job shadow sites). **Establishing stronger social media presence via LinkedIn and Mercer County ESC Facebook to increase awareness.

Initiative 2 Address the Need for Essential Skills Development for Career Readiness (8/10) **An active subcommittee is creating consistent language, exploring curriculum options and working to implement the Ohio Means Jobs Career Readiness Seal into classrooms. **Updates to Hometown Opportunity are ongoing.



Build Partnerships

Initiative 1 Develop a communication vehicle and systematic network for businesses and Schools

(7/10) ** The Mercer County ESC BAC's website was completely overhauled with new features and updated information. **Newsletter is in final stages of development. **A SOCHE intern is in the process of being explored and finalized. **Hometown Opportunity continues to be used and expanded. **Marketing committee is still working to identify student ambassadors and consistent funding options for promotional materials.

Initiative 2 Work collaboratively to provide high quality job shadow experiences in our region (8/10) **Hometown Opportunity Job Shadow indicator has been promoted extensively. **A Job Shadow Tool Kit, a compilation of best practices, templates and forms for job shadows from both schools and businesses, is in the final stages of development. **Follow-up strategies for students are also being developed as part of this tool kit.

Coordinate Experiences

Initiative 1 Implement Pre-Apprenticeship Opportunities for high school seniors.

(7/10) **A pilot cohort for the "Introduction to Advanced Manufacturing" Pre-Apprenticeship is in progress. **Work-based learning is the focus of the Spring BAC Quarterly Meeting and will feature an overview, funding options and a student success story as an in-depth information session. This topic is in direct response to a request by participating BAC schools and businesses.

Initiative 2 Raise awareness of industry-recognized credentials, graduation seals, and how graduation requirements can be recognized and valued in the workplace.

(8/10) **In coordination with the committee charged with evaluating essential skills development, industry-recognized credentials are being explored and promoted throughout our districts. **Options to help students unable to attend CTE, for various reasons, are being explored as alternative options for industry-recognized credentials.

- a. What challenges have you experienced implementing your goals?
 - **Funding sources for marketing materials, assessment tools (YouScience and Find Your Grind), and transportation. **Changes in leadership impacted financial resources via AMBE.
 - **Hometown Opportunity web administrators are slow to implement large changes.
- 3. What new partnerships have your Business Advisory Council formed for the SY24?

 **Relationships are being built within the Ohio Department of Education and Workforce, whose staff are now attending and presenting at our BAC Meetings, as well as SOCHE, who has aided a local company with pre-apprenticeship wage funding. Additional business partnerships include the Mercer County Sheriff's Office, S&K Products, VTF, Koesters Law, Moeller Real Estate, Mercer County Commissioners, Performance Physical Therapy and Wellness, VentureLINX, Stammen Insurance, Everheart Home Hospice, Above & Beyond Daycare, Wabash Telephone and JW Production, among others.
- **4.** Have you added or removed any goals submitted in your SY24 Business Advisory Council Plans? If so, please provide details.
 - No. However, the review of STEM Ecosystem grant proposals has been delayed, so that related objective may change depending on the adjusted timeline.
