The Board of Education of the Oregon City School District met in a special session at Clay High School Learning Center, November 4, 2020 at 6:15 p.m. President Carol Molnar called the meeting to order, led the pledge of allegiance to the flag and called for a moment of silence. Upon roll call the following members were present: Mr. Csehi, Mrs. Molnar, Mrs. Miller, and Mr. Ziviski. Mr. Kennedy answered roll call, and participated in the special meeting through the Zoom application as allowable under House Bill 197.

Mr. Csehi made a motion, seconded by Mrs. Miller to approve the agenda as written.

Upon roll call all members voted yes. President declared the motion passed.

ADJUSTMENT TO 2020 FEES

Mr Ziviski, Co-Chair of the Finance Committee, led a discussion on how the Board wishes to handle building fees, Career Tech Fees and Pay to Participate fees when classes were remote and seasons were shortened due to Covid19.

Finance committee had met October 29, 2020 and prepared a rationale for reducing fees based upon days in session, games played, etc. Board asked questions and additional review is planned for future finance meetings and the November 17, 2020 regular meeting.

Mr. Ziviski also mentioned that finance committee had discussed a potential deferring of Music Booster payment for the Press Box due to lost fund raising opportunities in both Spring and Fall of 2020 due to Covid19. More information is being collected at this time.

SUBSTITUTE TEACHER COMPENSATION

Finance Committee also reviewed the idea of increasing pay for substitute teachers from \$100 per day up to \$125 per day starting November 13, 2020 through May 28, 2021. This rate would go back to \$100 per day on May 29, 2021 and be reviewed for next school year. Board asked this be on agenda for our Regular board meeting in November.

2021-22 AND 2022-23 CALENDAR DISCUSSION

Mr. Kennedy led a discussion about starting school later in future school years to accommodate parental wishes. Mr. Gregory replied that he would look back at prior surveys to see what parents wanted and look for ways to push back professional development days.

SUPERINTENDENT UPDATE

Mr. Gregory discussed the district COVID response and how staff and students are adapting. We are very lucky to have our nurses and a wonderful relationship with Mercy Health. We are doing everything possible to keep students and staff as safe as possible under current situation.

Mr. Csehi made a motion, seconded by Mrs. Miller to adjourn. Motion passed. Meeting was adjourned at 7:27 p.m.
