The following actions were taken by the Northwest Ohio Educational Service Center Governing Board at their regular meeting held August 26, 2025.

The meeting was called to order at 6:00 p.m. by President Kelly Hug. All in attendance recited the Pledge of Allegiance.

#### **REPORTS:**

- •CFO/TREASURER: Mrs. Abby Lorenzen reported that ODEW had released additional 2025–26 grant allocations for Board approval, with Early Childhood Special Education and IDEA-B allocations still pending. She stated that she and Mrs. Weir are in the midst of processing the FY 2025 High Performing ESC application. While no longer tied to state funding, the application remained necessary for districts to obtain a federal procurement waiver. Mrs. Lorenzen explained that Putnam Investments was transitioning to Franklin Templeton, which was not yet a Board-approved provider. She would be requesting approval to ensure employees' contributions continued without interruption. She reported that the Walmart Community Program would end November 1, 2025. The ESC was enrolling in Walmart Business to maintain tax-exempt purchasing and invoice payment. Finally, Mrs. Lorenzen recommended Jill Peters for the Fiscal Consultant position, citing her 20 years of experience as both assistant treasurer and treasurer. She expressed confidence that Ms. Peters would be an excellent addition to the team.
- •DIRECTOR OF SPECIAL EDUCATION: Mrs. Jill Gilliland shared that all of our teacher positions are filled! We have new teachers at Archbold, Wauseon, Holgate, Patrick Henry, the IEC, Northeastern and Edon. Thank you to Alissa Brown, Troy Merillat, and Kris Ritter for meeting with new teachers in the afternoon at our fall staff meeting to help them prepare for their new roles. We continue to make steady progress in hiring paraprofessionals, with just a few positions left to fill. Thank you to the entire team who worked to get the building prepared and looking fantastic for the first day of school. The IEC team with support from the main office cleaned, painted, and put classrooms together after contracted work was completed. The school looks wonderful! We're excited to launch our new Five Star Registration system, which offers many features to streamline our work. A big thank-you to Jessica Fredrick, J Nichols-Ewing, and Jackie Fouty for their summer-long efforts to make this possible. More details about the system will be shared soon.
- •DIRECTOR OF CURRICULUM, INSTRUCTION, & PROFESSIONAL DEVELOPMENT: Mr. Andy Hunter reported that the ESC hosted its annual administrator conference on August 5th, featuring keynote speaker Tom Speaks from The Impact Group, who presented on the art of appreciology. Attendees also received legal updates, heard from their associations, and were addressed by Randy Gardner from CORUS. The event served as a strong kickoff to the school year for area administrators. Shortly after, staff gathered for the annual fall meeting, where keynote speaker Katie Peters delivered a heartfelt and impactful message. Next, Mr. Hunter shared that Ohio's new statewide student cell phone ban requires districts to adopt policies by January 1, 2026, though many have already implemented the rule at the start of the school year. The ban covers all school-day periods, including lunch, passing times, and field trips, with exceptions for medical needs. Finally, he pointed out that school report cards are expected to be released in mid-September, reflecting last spring's state testing and district data. In October, the ESC will host training on the new "College and Career Readiness" component, in partnership with the department.
- •DIRECTOR OF TECHNOLOGY & OPERATIONS: Mr. Chad Rex reported that he and Mr. Corey Todd have been working together in this especially active year to address new hire needs and departmental projects. He highlighted progress on the main office network closet project with the installation of a new switch and the reorganization of the network rack, while the IEC network closet is awaiting a new switch for installation. He stated that the ParentSquare app has now been set up and rolled out for use at the IEC as well as Defiance and Montpelier preschools. Mr. Rex also noted his participation in a cybersecurity webinar hosted by the State of Ohio and added that he has registered for a follow-up session. He emphasized that ongoing work continues in response to the ESC's recent audit and report. Mr. Rex highlighted the completion of the IEC renovation project just in time for the school year, expressing gratitude for the dedicated work of IEC leadership, staff, and the Operations team of Mr. Chris Staup, Mr. Larry Davis, and Mrs. Crystal Blevins. He described the final outcome as outstanding. He reported that the implementation of OMEC's new phone system is in process and scheduled to be completed within the coming week. Mr. Rex expressed appreciation for the efforts of Mr. Davis and Mrs. Pat Turpening in assisting a group of new ESC drivers toward certification. He noted that the ESC now has 13 drivers, including three with bus certification, and expressed gratitude for Mr. Ken Muntz, who has served as both OBI and substitute bus driver, covering the IEC route at the start of the year. Finally, Mr. Rex shared that the annual driver in-service training was a resounding success thanks to the ESC team's planning and coordination, Archbold Schools' hospitality, and training provided by the Ohio Schools Council. He celebrated the increased attendance, with 372 drivers

participating this year from 19 member districts and 3 non-member districts and stated that planning for next year's training is already underway.

## **INFORMATION/DISCUSSION ITEMS:**

- The Combined Calendar 2025-26 an " At-a-Glance" calendar of member district school schedules was shared with the board. All districts are now in session for the school year.
- The OSBA Northwest Region Fall Conference will be held on Thursday, 10/2/2025; 5:30 PM 8:30 PM; at Hull Prairie Intermediate School in Perrysburg.
- A review of the NwOESC Board of Education candidate filings for the November 2025 General Election Candidate was provided.
- Four County Career Center Appointments for January 1, 2026 December 31, 2028 will be completed
  this fall. Both Nona Rupp and Brian Baker are interested in continuing to serve on the FCCC Board.

•SUPERINTENDENT'S REPORT: Superintendent Kerri Weir reported on several items of importance to the Northwest Ohio ESC as the 2025–26 school year begins. She noted that the federal funding freeze has officially been lifted, with all FY25 funds for Title I, Part C; Title II, Part A; Title III; and Title IV, Part A now released. Title IV-B funds had already been restored earlier this year. With approximately \$1.245 million in annual federal support flowing to NwOESC, this action ensures uninterrupted services for migrant students, English learners, and those who benefit from afterschool and summer programming. Superintendent Weir emphasized that both local and statewide advocacy were critical in pressing the Office of Management and Budget to act, and she pledged to continue monitoring future developments. Weir highlighted the success of the annual Administrators' Conference, held August 5. The event brought together superintendents, treasurers, principals, and other leaders from across the region, along with representatives from Four County Career Center and NWOCA. The conference provided a strong kickoff to the school year, offering opportunities for professional networking and collaboration. She also reported that Marathon Health, formerly known as Activate and Everside, is undergoing a rebranding with new exterior signage at its healthcare clinic sites. Marathon Health continues to provide valuable in-person and virtual services for staff members enrolled through the NBHP/Buckeye Advantage consortium. Services include primary and preventative care, medications, immediate and sick care, lab services, health coaching, condition management, and mental health counseling for individuals ages 13 and older. Clinics are available in Archbold, Bryan, Defiance, Napoleon, and Wauseon. Superintendent Weir expressed gratitude for the strong turnout at the

annual Fall Staff Meeting on August 7, which welcomed nearly 380 staff members. The theme, "Building Connections is HEART Work!" quided the day, which featured an inspiring keynote by Dr. Katie Peters, timely updates, service recognitions, and celebratory activities including food trucks and lunch together. She was especially pleased to recognize milestone service anniversaries across the ESC: those marking five years included Makayla Babcock, Lauren Beers, Larry Davis, Abigail Hiler, Andy Hunter, Amy Neff, Rachel Norden, Bethany Russell, Patricia Shotwell, Patricia Sutter, and Stephanie Tyson. Ten-year honorees were Kristy Gerig, Kristan Hughes, Katherine Maloney, Tina Rufenacht, Lexie Semer, Kendall Shively, Jason Stein, Page Warner, and Jenna Wilhelm. Fifteen years of service were celebrated for Ami Allison, Megan Hensley, Gail Mason, Lisa Meeker, and Matthew Shumaker, while Sara Buchenberg, Dawn Hill, Jenifer Kitchenmaster, Jodie Mack, Scott Nixon, and Dawn Rufenacht reached the 20-year mark. At 25 years, Denise Baden, Susan Benson, Maria Hernandez, Kristina Keller, Jose Salinas, and Deborah Schmitz were honored. Glenda Funnell, Catherine Gribler, Catherine Millen, and Brandi Sabatino reached 30 years, and a special recognition was given to Margaret Falkenberg for her remarkable 41 years of service. Looking ahead. Weir announced that the first Superintendents' Meeting of the year will be held September 16 in conjunction with the Business Advisory Council (BAC). The BAC, co-chaired by Weir, Andy Hunter, and Mike Remer, meets quarterly to strengthen business-education partnerships across the region. Superintendents will also meet monthly to share updates, address regional challenges, and collaborate with treasurers and legal counsel. Superintendent Weir further reminded staff of available student loan forgiveness programs, directing them to NwOESC's website for more information. She also shared that she will be honored with the Jerry Klenke Leadership Award at the BASA Fall Conference, noting her gratitude for the opportunity to serve as Region 1 Representative on the BASA Executive Council. Finally, she encouraged continued use of the Ohio ESC Association's online resources, which provide videos, infographics, and materials to help share the impact of ESCs with local stakeholders.
