**State Support Team - Region 8 seeks a full-time team member who will have a dual focus on supporting continuous improvement (e.g., Ohio Improvement Process) and the use of evidence-based structured literacy instructional practices for adolescent learners.**

**PRIMARY POSITION DUTIES INCLUDE (but are not limited to):**

- Provide job-embedded coaching, professional development, and technical assistance to district/building/teacher teams on the Ohio Improvement Process and implementation/monitoring of improvement efforts;
- Support school districts, buildings, and community schools in the analysis of local data to identify critical needs through the One Needs Assessment, and in the development of continuous improvement strategies and action steps through the One Plan;
- Provide professional development, coaching, and technical assistance on implementation of evidence-based practices in literacy instruction at the system, building, and classroom level, with a focus on adolescent literacy. Specific topics or supports might include analyzing student outcome data across a variety of assessment types, assessing implementation of Tier 1-3 instruction within a multi-tiered system of support (MTSS) framework, conducting curriculum/assessment inventories, and modeling specific practices aligned to the science of reading; and
- Serve as SST8 Regional Data Lead: foster a culture of data reliance by promoting a consistent understanding of education data through offering technical assistance to school administrators and teachers.
- Assist in documenting the work of the State Support Team and analyzing district/regional data to determine ongoing support needs.
