Targeted Assistance Program

St. Thomas Aquinas is a Title I Targeted Assistance School. Our school receives funding through the Canton City School District. This federal funding is used to <u>supplement</u> our school's existing programs. These funds are used for...

- Identifying students who reside in the Canton City School District experiencing academic difficulties and providing timely assistance to help students meet the State's content standards.
- Hiring teachers and supplemental staff
- Purchasing programs, materials, and/or supplies.
- Conducting parental involvement opportunities

Title I Program

Program Outline

- Students are identified using the following criteria
 - Teacher recommendations
 - Standardized test scores
 - Middle School: MAPS Testing
 - Fall, Winter, Spring
 - High School:
 - IOWA Grades 9-12
 - ACT Grades 11-12
 - Informal Assessments

Title I Program

- Identified students are selected based on the criteria and put on an eligibility list.
- Eligible students receive assistance using the following methods:
 - Teachers provide intervention during classroom instruction
 - Small group instruction
 - Students receive intervention during study halls
- Student eligibility is reviewed monthly by classroom teachers and Title I teachers.

 St. Thomas Aquinas follows a graded course of study developed and supported by the Diocese of Youngstown.

Proficiency

 St. Thomas Aquinas works to provide a learning environment that will assist students to achieve a level of proficiency in all classes.

- The diocesan graded course of study implements Ohio's Learning Standards and religion standards from the Diocese of Youngstown
- All schools in the Diocese of Youngstown are accredited by the State of Ohio.

School Accreditation - OCSAA

About OCSAA

In 1994, the Bishops of Ohio formed the Ohio Catholic School Accrediting Association (OCSAA). The OCSAA is a collaborative undertaking of the Catholic dioceses in Ohio and is governed by the Superintendents of Schools who serve as the OCSAA Commission. The purpose of the OCSAA is to strengthen Catholic school identity and mission and to engage Catholic schools in the ongoing improvement of student learning.

The purpose of the OCSAA is to strengthen Catholic school identity and mission and to engage Catholic schools in the ongoing improvement of student performance.

School Accreditation-OCSAA

OCSAA accreditation also requires schools to show evidence that they are implementing OCSAA Standards. The State Board of Education has approved these Standards as comparable to the ODE's Operating Standards for Ohio's Schools.

Through the OCSAA accreditation process, a new Catholic school can apply for a charter from the state of Ohio and existing Catholic schools can maintain their state charters.

The accreditation process is renewed every five years. St. Thomas Aquinas is in year one of a new accreditation cycle. Teachers and staff are reviewing data and are in the process of creating two new goals to implement for school improvement.
