HOW DOES THIS ALL WORK?

Ohio Revised Code 3365 established a College Credit Plus Program, which allows college-ready students in grades seven through twelve, who qualify for college admission (each college has set its own criteria for student eligibility), to take college-level courses while in middle school or high school. These students will earn college credit and high school graduation credit through the successful completion of college courses.

The purpose of the program is to promote rigorous academic pursuits and expose students to options beyond the high school classroom. Students still must take Ohio State Tests, depending on the subject area.

Students/Parents must notify the school Prior to April 1st of the previous school year of their intent to participate in the College Credit Plus Program. Students/Parents must sign a form indicating that appropriate counseling was provided and all responsibilities for participation are understood.

QUESTIONS & ANSWERS

How can I sign up?

Contact Mrs. Wiley (MS Counselor) or Mrs. Lott (HS Counselor). obtain an Intent to Participate form and turn it in to the Student Services office by April 1st. If you are taking a class at MHS make sure to request the class on your proposed class schedule for next year.

What can I expect after signing up for a CCP class being taught at MHS? Once students have requested to participate in the program, Mrs. Wiley & Mrs. Lott will hold a meeting in the MHS cafeteria. A representative from Rhodes State will also be in attendance. All students will bring their Chromebooks to the meeting. Students will be assisted in applying to the appropriate college at the meeting. Transcripts will then be sent from MHS to the college. When the student qualifies for admission they will be notified. If a student does not qualify they will be required to take and pass a college entrance exam (accuplacer test).
