



## The Adrian G. and Anne M. Werst Scholarship Application 2019

The Masonic Temple Company of Wapakoneta is pleased to be able to offer scholarships to eligible students through the Adrian G. and Anne M. Werst Scholarship Fund.

Scholarships will be offered annually to high school senior(s) whose father or grandfather is, or at the time of his death was, a member in good standing within the 10<sup>th</sup> Masonic District under the jurisdiction of the Grand Lodge of Ohio, F. & A.M. The applicant must reside within the 10<sup>th</sup> Masonic District, which is defined as one of the following counties: Allen, Auglaize, Hardin or Hancock within the state of Ohio. The award must be used toward the tuition and other related educational expenses at an accredited college, university, vocational or technical school.

### **To be eligible for consideration, applicants must:**

- ❑ Provide evidence of acceptance at an accredited college, university, vocational or technical school.
- ❑ Have a 2.5 cumulative grade point average on a scale of 4.0 points.
- ❑ Submit a completed application form which must be accompanied by:
  - ❖ A recent letter of recommendation from a teacher or an employer.
  - ❖ A most recent grade transcript.
  - ❖ A 400-600 word essay outlining educational/career goals.

Criteria for selection include: academic performance and participation in school and community activities, a recommendation and an essay.

The Board of Trustees of the Masonic Temple Company will convene a Selection Committee. The Committee may elect not to award scholarships if, in its judgment, suitable candidates cannot be identified.

The application must be postmarked no later than APRIL 19, 2019
