Student and Parent Commitment and Agreement Verification



As part of the application process for the Sylvania Alternative Learning Academy (SALA), I am committing to and verifying the following expectations:

- I understand that my family and child enrolled in SALA are making a commitment to a minimum of one semester of enrollment in SALA. Changes to enrollment cannot be made mid-semester.
- I understand that it is my responsibility to have reliable and consistent access to the Internet when working on the courses outlined in my SALA program.
- I understand that my child enrolled in SALA must use the district's provided technology when required.
 - I will obtain a district-owned Chromebook and will treat it as such.
 - I have read and reviewed with my child the [Board of Education Policy 7540.03](#) and have agreed to the Acceptable Use Policy in the OneView Portal.
 - Students are expected to turn on their camera for live sessions and maintain active engagement in learning activities, and I will make sure my child does so.
- I understand that my family and child enrolled in SALA will maintain residency and occupancy in Sylvania Schools throughout the 2021-2022 school year.
 - I understand that *occupancy* means that my child resides in the Sylvania district and does not share occupancy with another, out-of-district location.
 - My child and family will maintain occupancy within the district in order to provide and pick up physical materials, attend testing sessions, and respond to other in-person needs.
- I understand that my child enrolled in SALA will be engaged in learning during normal school hours.
 - I have read and reviewed with my child the [SALA Student Expectations](#) document.
 - I will adhere to attendance requirements for live meets and virtual check-in policies/requirements for my child's grade level.
 - I will adhere to the school's timelines for the completion of course requirements.

- I understand that the courses will be listed on my child's transcript or progress report. The grade assigned will be part of their record and will be included in their cumulative Grade Point Average (GPA) where applicable.
- I understand that in order to support my child's learning, teachers may require small group and individual intervention.
- I understand that the delivery of special services may be through remote means or in-person meetings. These services include related services of OT, PT, and SLP as designated on the IEP, 504, gifted, ESL, related, and intervention services.
- I understand that SALA will conduct regular instruction and engagement in line with the district calendar, including five-day instruction, calamity days and school delays, teacher professional development/conference days, and holidays.
- I understand that my family and child enrolled in SALA will practice and maintain ethical behavior while learning remotely.
 - My child is expected to adhere to the highest codes of conduct and integrity as a representative of my school district.
 - I have read and reviewed with my child the [Academic Dishonesty Statement](#). In following this policy, students and parents maintain academic integrity guidelines and requirements from Sylvania Schools, avoiding dishonesty, cheating, and plagiarism.
- I understand that my child enrolled in SALA is not exempt from district-wide testing. This may include OELPS, OELPA, Iowa, CogAT, Ohio State Tests, State ACT, and special education testing.
 - I understand that all state-mandated testing must be completed face-to-face, on campus.
 - I understand that transportation will not be provided for the dates that my child is testing.
- I understand that participation in my child's education will help determine his/her likelihood of success in the program. Therefore, I will monitor and support my student in his/her studies, recognizing that time management and attendance is vital to my student's success. I agree to be accessible and readily available to Sylvania Schools SALA staff members to discuss my child's progress and development.

Failure to follow these policies may result in dismissal from the Sylvania Alternative Learning Academy.
