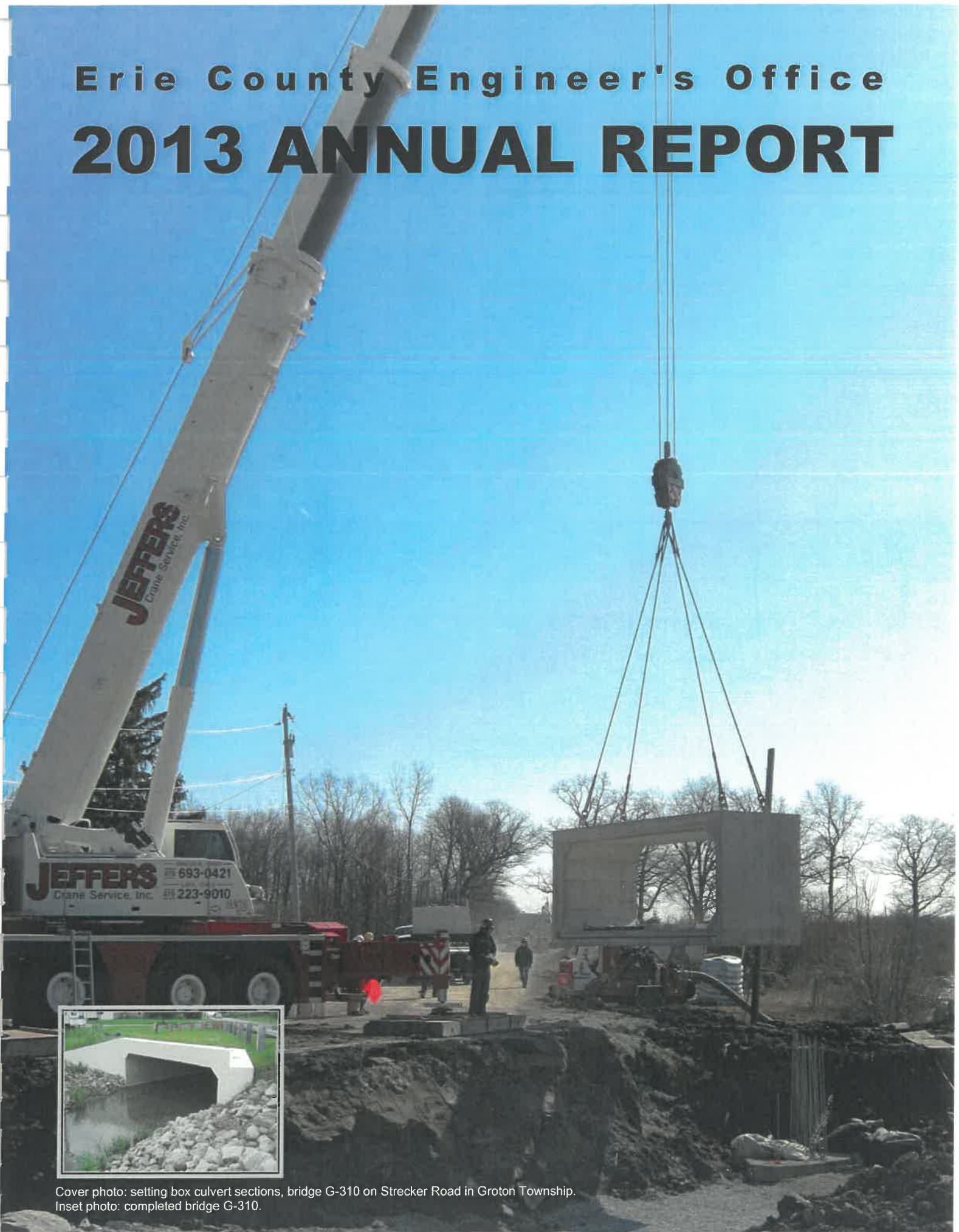

Dear Commissioners:

Submitted herein is the Erie County Engineer's Annual Report for 2013 encompassing county highways, bridges, drainage, ditch maintenance and tax mapping.

- We continue to maintain our county highway systems, within budget, in keeping with the demands placed upon them. In 2013, approximately 2.5 miles of our county and township roads were resurfaced, another 54.15 miles were seal coated and 2.893 miles of Campbell Street and Strecker Road received a Reclamite Treatment. Additionally, 546.298 miles of roadway striping was completed throughout the county as we persist in our efforts to have the safest possible roadway systems by clearly defining them. Also, our roads' rights-of-way were mowed three times during the year to maximize visibility at our intersections and beyond, while minimizing conflicts with wildlife and drifting snow. 16 traffic studies were completed, 4 of which were relative to speed and 12 were traffic volume studies. Other miscellaneous work included repairing approximately 10 lane miles of berm countywide and wedge coating prior to surface treatments throughout the county.
- Application were prepared for grant funding for resurfacing roads project which have been committed to Erie County in the amount of \$275,000 during 2014.
- Chip seal was performed by Lloyd, Porter and Porter throughout the county including Berlin, Groton, Margaretta, Milan, Oxford, and Perkins Townships at a total cost of \$730,269.
- Berlin Township completed chip seal work throughout the township on 9.07 miles of various roads at a cost of \$101,982.
- In Florence Township completion of the Dean Road bridge renovations are delayed until Spring 2014 due to various unforeseen conditions which have added approximately \$468,000 (33%+) to date to the overall actual project costs and still counting.
- Groton Township completed chip seal work throughout the township on 2.46 miles of various roads at a cost of \$27,701. The Burdette Ditch flood prevention project was finalized at a total cost of \$157,000.

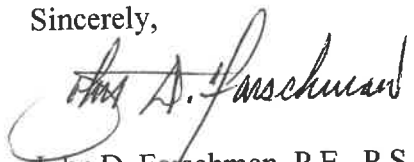
- In Huron Township Camp Road reconstruction was completed in the spring with a final cost of \$766,065. The Knight Road widening projected contracted to Burdue Construction at a cost to date of \$1,043,835 and Greentree Lane was totally removed and replaced by Dellinger Excavating at a final cost of \$150,793. Gerken Paving completed 1,246' of pavement repair on Camp Road at a final cost of \$46,843. Microsurfacing was completed on 1.66 centerline miles (21,539 sq. yd.) on Galloway Rd, Valley Lane, Autumn Dr, Brookside, Hill Top, Woodside by Strawser, Inc., at a final cost of \$72,660.
- Margaretta Township chip seal work was completed on 3.05 miles of various roads throughout the township at a cost of \$37,035. The Issue II Old Railroad Road repair and resurfacing (chip seal) by Erie Blacktop was completed at a final cost of \$46,786.
- Milan Township chip seal work was completed on 3.33 miles of various roads throughout the township at a final cost of \$40,745. 0.62 miles of Edgewood Estates and Diehl Road was repaved with asphalt by Precision Paving at a final cost of \$107,410.
- Oxford Township chip seal work was completed on 1.71 miles of various roads throughout the township at a cost of \$20,643.
- Perkins Township chip seal work was completed on 0.19 miles on Miller Road at a cost of \$1,925. Lakecrest Town Center was finally accepted December 13, 2012.
- Vermilion Township completed miscellaneous repairs on Frailey, Hickory, Kneisel, Sassafras at a cost of \$31,878. 11,281 s.y. of microsurfacing was completed on Wine and Chardonnay at a cost of \$36,324. 100' of West Bailey Road was paved at a total cost of \$5,785.
- Village of Berlin Heights asphalt work was completed on Memorial Drive by Gerken Paving at a cost of \$34,208 funded in part with CDBG monies.
- Design work continues for various bridges, road resurfacing, chip seal and drainage projects to be constructed in 2014. We remain committed to pursuing grant funding whenever possible for these projects.
- Contracted to Schirmer Construction removal/replacement of a portion of Mason Road Structure B-308, including the entire pavement and waterproofing of deck at a final cost of \$159,654.
- Contracted to Denes Concrete for the replacement of bridge structures G-310 and O-308 on Strecker Road and Mason Road. Total costs to construct was \$211,196 plus the Precast Materials provided by Lindsay Concrete for an additional \$88,060.
- Bid replacement of the Thorpe Road Bridge Structure B-214 but with only (1) bid received, decided to rebid in the winter of 2014 in hopes of more competition. In the mean time we found we may qualify for grant funding through the OTC for this project and are presently pursuing that possibility.
- Replaced beam on Berlin Street Mi-404 (Milan Twp), waterproofed and resurfaced at a total cost of \$26,343. Force Account

- Replaced (2) beams on Smith Road G-108 (Groton Twp), waterproofed and resurfaced at a total cost of \$34,051. Force Account
- Removed and replaced asphalt and waterproofing entire Garfield Rd structure F-204 (Florence Twp) at a total cost of \$40,757. Force Account
- Removed and replaced asphalt and waterproofing entire Strub Road structure P-322 (Perkins Twp) at a total cost of \$29,100. Force Account
- Bridge inspections were completed on January 31, 2014 and the final reports are currently being prepared for submittal to the county commissioners.
- Repair of 150 expansion joints and wedge coat 5.2 lane miles of Barrett Road and prior to chip seal project.
- Crack sealing was completed along 70 lane miles of county roads.
- Removed and replaced Chapin Road Culvert #B-329 (Berlin Twp) and replaced with 72 l.f. of 36" diameter R.C.P. at a total cost \$28,908. Force Account
- Removed and replaced Mason Road Culvert #O-309 (Oxford Twp) – approximately 116 l.f. 54" diameter at a total cost of \$48,977. Force Account
- The total numbers of drainage systems now under ditch maintenance is 123 plus the 3 joint county ditches maintained by Sandusky County remaining at a total of 126.
- 16 residential, government and commercial site plans were reviewed for compliance with our county Stormwater/Erosion Control drainage regulations.
- Lake Erie Construction replaced 20,300 l.f. of guardrail along Barrett Road with a 100% safety grant in the amount of \$245,578.
- OPWC funding of \$72,300 committed to Perkins Avenue Signal Project (FY 2014).
- Columbus Ave, Bogart Rd and Bardshar Rd Signal Upgrade completed by National Light and Power at a cost of \$15,400.
- Speed studies were completed on Bell Avenue, Marshall Avenue, River Road and Strub Road and traffic volume studies were made on Joppa Road, Thorpe Road and Strecker Road.
- Received \$20,152 BWC grant for Challenger lifts to be installed at the county highway garage.
- Salt bids were taken for 2014 and a contract let to Morton Salt at \$27.75/ton picked up at the dock, a 15.9% decrease in price compared to the 2013 contract.
- In our tax mapping 3,229 parcel transfers were processed through December 31, 2013, up 219 from those in 2012.

The county engineer's staff and field supervision strive to achieve high, yet achievable goals. Although we continue to be faced with financial challenges due to sinking MVGT revenues and losses in grant funding because our bridges are now in to good a condition to qualify, we remain focused and committed to maximizing our accomplishments within our available financial resources while serving our citizens professionally and responsibly.

This summarizes the major contributions of the Erie County Engineers to the citizens of Erie County that were accomplished during 2013.

SURVEY & FIELD WORK

The work performed by Dave Williams, our surveyor, and his crew, Amanda Buser and Mike Farrell encompasses, but is not necessarily limited to the following:

County and Township Roads, Bridge and Culvert work, Miscellaneous Drainage Projects and Property Locations for Easements. *The Scope of Field Work includes but is not necessarily limited to: (1) Determination of centerline control (set monument boxes), (2) Topography, (3) Cross Sections, (4) Drainage and further; construction layout consisting of: (1) Slope staking (2) Layout of structures (3) Setting grades and (4) Final quantity determinations.* Also now collecting data countywide using GPS instrument.

Also, County and Township Road Resurfacing Projects and determination of total quantities completed.

Assist in Traffic Studies, pavement marking and signage.

Survey Office Work for the general public which consists of: *(1) Researching Lot splits (2) Verification of closure of all Subdivision Plats and lots (3) Research the Right-Of-Way (4) and assist the Public when, and as necessary.*

The Survey Department researches records for centerline; records fieldwork notes; and writes all easements for the County Engineer or other County Officials.

BRIDGE REPORT

GENERAL

As per various sections of the Ohio Revised Code, the Erie County Engineer is required to inspect, maintain, and, where determined necessary, replace any highway bridges for which the county is responsible.

BRIDGE INSPECTION

The Erie County Engineer's Office inspected a total of 137 highway bridge structures for the year 2013, wrapping up physical inspection work on January 31, 2014. The Federal Bridge Inspection standards and procedures were applied during these inspections, as mandated by federal law.

Additionally included is an outline of those structures currently scheduled for major rehabilitation or replacement between now and the year 2020, and their associated individual budgeted costs.

BRIDGE REPLACEMENT AND REHABILITATION WORK

Two bridges were replaced during the year 2013:

- G-310 on Strecker Road in Groton Township
- O-308 on Mason Road in Oxford Township

One bridge was comprehensively rehabilitated:

- B-308 on Mason Road in Berlin Township

NOTES ON YEAR 2013 TRAFFIC STUDIES

- Completed a total of 16 traffic studies.
- Conducted four studies to change existing speed limits. Three studies were for speed limits on county roads and one for a township road. One study resulted in the revision of an existing speed limit zone, two studies did not result in changes to the existing speed limit, and one study is still in progress.
- Conducted a total of 12 traffic volume studies. Many of these volume studies were to determine traffic volumes for various proposed township and county projects, especially projects with Ohio Public Works or CDBG funding. Traffic counts allow appropriate design criteria, such as signal timing, lane and shoulder width, and pavement thickness, to be accurately determined and designed.

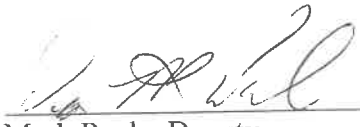

ERIE COUNTY DITCH MAINTENANCE
ANNUAL REPORT

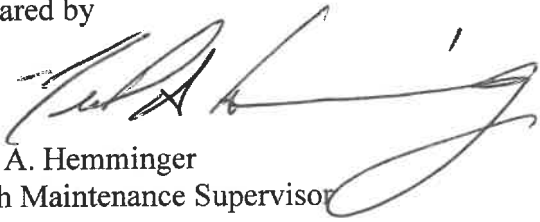
This was another productive year for improvements made to Erie County Maintenance ditches, tile systems and subdivisions under the care of this department. There were 23,735 linear feet of ditch reshaped, realigned, dipped and/or had debris removed to allow for normal flow as well as to provide adequate freeboard for tile outlets. There were 1,360 linear feet of brush trimming and clearing. Also 15 rock structures were installed which required 198 ton of stone being placed. Additionally 1,680 linear feet of various size tiles were repaired or replaced. (Check the following chart for a work summery of all projects)

The mowing program started in late summer continuing thru fall when weather allowed. Twenty ditches, 57,146 lineal feet have been completed. The balance of the ditch mowing should be finished by spring of 2014. This mowing program allows for a more economical application of herbicides by not wasting the solution on last year's dead vegetation and still allows for wildlife nesting and habitat utilization.

Ditch Maintenance has 52 subdivisions with 46 detention basins that need regular spraying and maintenance. Twenty Four of the detention basins were again targeted this year to address persistent and hard to control noxious weeds such as cattail and phragmite along with broadleaf and woody vegetation. This was accomplished with a rigorous spray program as well as mowing over 284,000 sq. ft. of dead or dying vegetation leaving a stand of grass.

One additional project for maintenance was received in 2013. This department now manages and maintains 126 projects that include 3 joint county projects, which have a combined maintenance bases of over \$15 million dollars.
