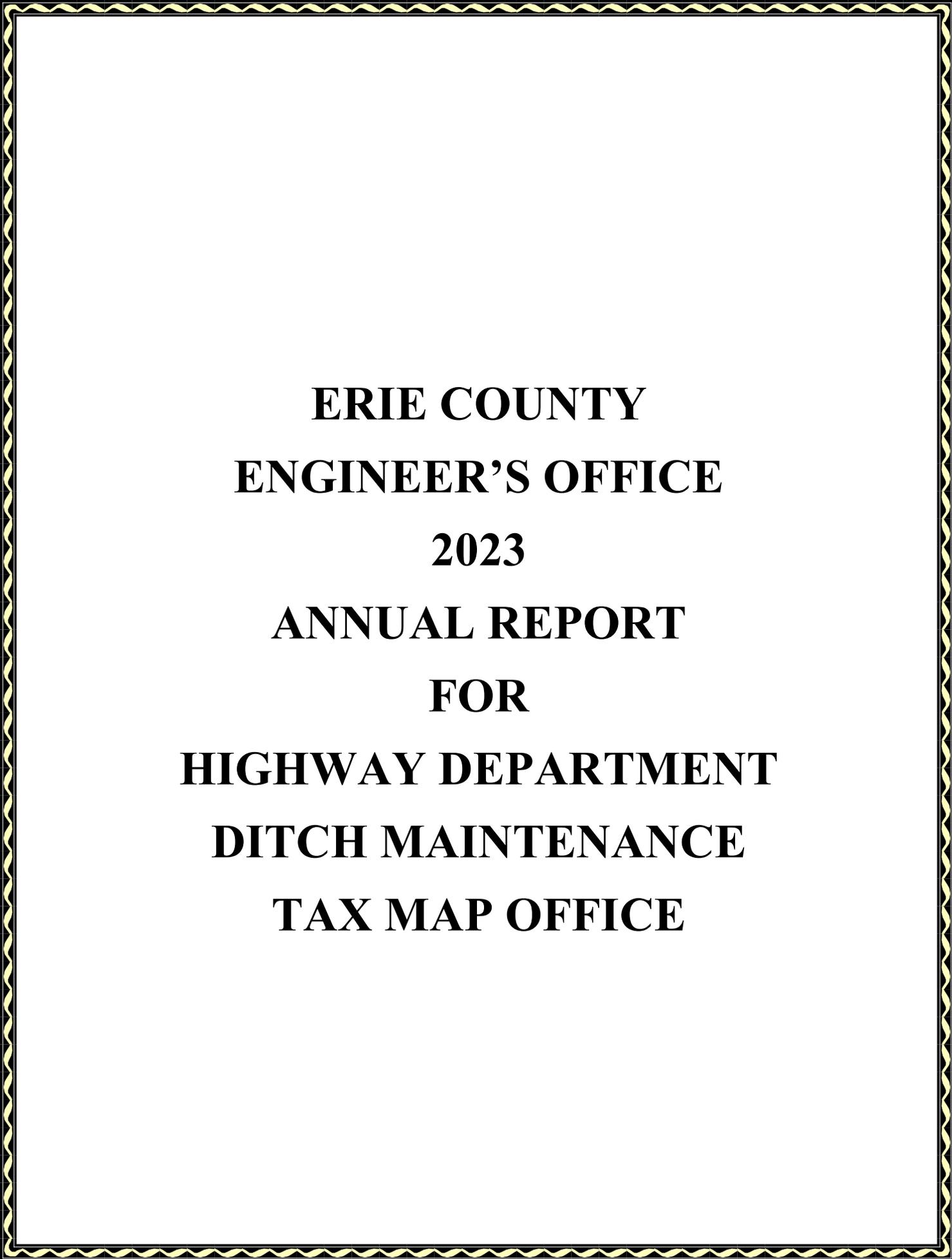

Dear Commissioners:

Submitted herein is the Erie County Engineer's Annual Report for 2023 encompassing county highways, bridges, drainage, ditch maintenance and tax mapping. Hi-lites of the work completed throughout Erie County last year are as follows:

We continue to maintain our county highway systems, well within budget with an uncommitted balance entering 2024, of approximately \$1,745,349, plus another \$1,000,000 commandeered yet again from our county MVGT revenues and given to the townships. Erie County did, for the first time, chip seal **with recycled asphalt**, 4.46 miles of Mason Road, and otherwise care for our system of roadways as proven most effective over the last 5 decades. In 2023, while there were no county roads resurfaced, 18.20 miles were microsurfaced. The townships resurfaced 20.71 miles of roads with chip seal, .39 miles with microsurfacing and 6.40 miles with asphalt totaling 27.50 miles in all. The townships also contracted independently for the application of reclamite over approximately another 4.78 miles. Additionally, 88.238 miles of center line striping along with 64.019 miles of edge line striping was completed. Comparatively, the county was financially able to complete only a combined total of 22.66 miles over the entire county of similar work. 147.070 miles of county roadway center line, 282.315 miles of edge line, 2.138 miles of lane lines and 2.41 miles of channel line striping were completed throughout the county. Also, our roads' rights-of-way were mowed three times during the year to maximize visibility at our intersections and beyond, while minimizing conflicts with wildlife and drifting snow.

- \* County contracted with Allied Construction LLC to chip seal with recycled asphalt 4.46 miles (66,024 s.y.) of Mason Road at a total cost of \$134,750.
- \* County contracted with Strawser Construction, Inc. to complete microsurfacing on 18.20 miles of various roads throughout the county at a final cost of \$1,033,658 and completed 0.39 miles of Riley Road for Milan Township at a final cost of \$19,292.
- \* County contracted with Great Lakes Demolition for construction of Bridge S-004 over Pipe Creek at a bid price of \$1,685,268. This bridge was opened to traffic November 22nd.
- \* County contracted with AMERICAN STRUCTUREPOINT for Inspection Services on Bridge S-004 over Pipe Creek at a cost of \$156,743.
- \* County contracted with AMERICAN STRUCTUREPOINT for design services for Huron River Bridge Mi-212 at a cost of \$317,224.

- \* Replacement of (4) culverts was completed on Barrett Road by Great Lakes Demolition at a final cost of \$177,585.
- \* Work was completed for Structure Ma-209 replacement on Bardshar Road by Kwest Group at a final cost of \$225,370.
- \* Work was completed on widening and resurfacing 0.609 miles of Bardshar Road by D-2 Excavating at a final cost of \$672,847 to Erie County and \$17,676 to Sandusky City.
- \* Striping – 147.07 miles of center line, 282.315 miles of edge line, 2.138 miles of lane line and 2.412 miles channel line was contracted for the county with Oglesby Construction at a final cost of \$197,626. Miscellaneous other striping was contracted for all the townships at a total cost \$76,440.
- \* 2022 Traffic Signal Upgrades were completed at a total cost of \$62,600 for Campbell Street - Strub Road and \$35,000 for Perkins Avenue - Strub Road intersections.
- \* Speed studies and traffic volume studies were completed on various roads throughout the county (ref. page 6).
- \* Thompson Interstate Mowing, Inc., Leesburg, OH, conducted roadside mowing throughout the county three times at a total cost of \$36,750.
- \* County forces performed stabilization maintenance on approximately 117.75 miles of berm along various roads at a total cost of \$190,223.
- \* Completed 3.38 lane miles of roadside landscaping along with brush and tree removals throughout the county and various townships.
- \* New salt bids were received and a contract was awarded countywide to Compass Salt at \$55.00/ton picked up and \$57.41/ton delivered for calendar year 2024. Last year's price was \$53.00/ton picked up and \$56.15/ton delivered.
- \* Material testing services were performed on various county projects by Bowser Morner at a cost of \$16,213 thru November 30, 2023.
- \* Soil boring testing were performed on Chapin Road Bridge B-401 and Mason Road Bridge O-310 by PSI at a cost of \$11,508.
- \* 14 multi-family residential, commercial and utility site plans received for compliance with the Erie County Storm Water and Erosion Control Regulations.
- \* 21 lot splits were reviewed for compliance to the Erie County Storm Water and Erosion Control Regulations.
- \* Auditor processed 3870 transfers thus far thru 12/31/2023, down 912 from 12/31/2022.
- \* County forces installed 383' of 8" HDPE pipe, 1,045' of 12" HP pipe, 8' of 12" HP pipe and 10 2-2b catch basins to close an open ditch on Skadden Road at a total cost of \$84,056.

- \* County forces installed 261' of 18" HDPE pipe, (3) 2-3 basins to close an open ditch on Ridsen Road at a total cost of \$25,350.
- \* County forces installed a 2-2b catch basin on Mason Road in Florence Township totaling \$2,004.
- \* County forces installed 28' of 8" SDR pipe and a 2-2b catch basin on Bogart Road in Perkins Township totaling \$4,084.
- \* County forces installed 1,284' of 12" HDPE pipe, 44' of 12" RCP and 7 2-2b catch basins to replace undersized drainage and close an open ditch on Ridsen Road at a total cost of \$112,563.
- \* County forces installed 42' of 12" RCP and a 2-2b catch basin for culvert H-224 replacement on Rye Beach Road at a total cost of \$17,819.
- \* Prepared force account estimate for resurfacing 1.128 miles (5,954') of Magill Road for Groton Township.
- \* Prepared force account estimate for resurfacing 0.373 miles (1,968') of Portland Road for Groton Township.
- \* Prepared force account estimate for resurfacing .46 miles (2,426') of Maple Avenue for Margareta Township.
- \* Prepared force account estimate for Bridge Ma-105 renovations on Skadden Road.
- \* Prepared force account estimate for Bridge H-418 renovations on Scheid Road.
- \* Prepared force account estimate for Bridge H-406 renovations on Hull Road.

**Berlin Township:** Township contracted with McB Paving to resurface the Berlin Township Fire Station and Garage parking lot at an estimated cost of \$169,023. Erie Blacktop, Inc. completed resurfacing 1.0 miles (12,089 s.y.) of Berlin Road at a total cost of \$168,655.

**Florence Township:** Township employees installed 12" drain tile and a catch basin at SR 60 and Garfield at a total cost of \$1,437. Township employees installed a driveway culvert and ditched out drain path on Angling Road at a total cost of \$1,387. Township employees applied 2,750 gallons of dura patch on various roads throughout the township at a total cost of \$10,677. Township employees applied 6 tons of cold patch to various roads throughout the township at a total cost of \$2,465. Township contracted with Precision Paving to wedge West River, Angling, Stephens N. and paved full width on Thorpe at a total cost of \$151,999. Township employees bermed roadsides on various roads throughout the township at a total cost of \$2,056. Township employees along with County road employees cleaned out drainage tile on Dean Road at a total cost of \$411. Allied Construction LLC completed chip seal work throughout the township on approximately 6.96 miles (74,699 s.y.) of various roads at a total cost of \$104,363.

**Groton Township:** Township contracted with Erie Blacktop to chip seal with rap cover aggregate on Billings Road and E. Smith Road at a total cost of \$73,106. Township contracted with Erie Blacktop to overlay and berm Magill Road for a total cost of \$155,123. Portland Road was paved and bermed from east of SR 99 to township line by OMG, Castalia, Oh at a total cost of \$41,531.

**Huron Township:** Allied Construction LLC completed chip seal throughout the township on approximately 3.71 miles (45,714 s.y.) of various roads at a total cost of \$82,460. Erie Blacktop, Inc. completed resurfacing .24 miles (3,943 s.y.) in Greenskeepers Subdivision and .21 miles (3,271 s.y.) on Autumn Drive at a total cost of \$124,709.

**Margaretta Township:** Township contracted with Gerken Paving for resurfacing 11,900' of Heywood Road with OPWC money at a total cost of \$275,544 with the townships cost at \$137,772. Township contracted with Erie Blacktop to chip seal 4,500' of Heywood Road and 5,715' of Thicket Road at a total cost of \$46,135. Township contracted with Erie Blacktop for pavement repair on Maple Avenue at a total cost of \$23,340. Township employees resurfaced and installed berm on 2,447' on Maple Avenue at a total cost of \$55,349. Township contracted with Pavement Technology to apply reclamite to 6,739' on Maple Avenue and 7,494' on Old Railroad Road at a total cost of \$16,369.

**Milan Township:** Allied Construction LLC completed chip seal work throughout the township on approximately 3.56 miles (41,732 s.y.) of various roads at a total cost of \$79,255. Erie Blacktop, Inc. completed resurfacing .17 miles (2,134 s.y.) of Warwick Drive and .80 miles (11,556 s.y.) in Twin Oaks Subdivision at a total cost of \$182,476.

**Oxford Township:** OMG resurfaced 2,065' of Portland Road at a total cost of \$42,708. Township employees placed berm stone on various roads throughout the township using 145.5 ton of #411 at a total material cost of \$1,739. Allied Construction LLC completed chip seal work throughout the township on approximately 6.48 miles (73,948 s.y.) of various roads at a total cost of \$121,867.

**Perkins Township:** Township contracted with Smith Paving to do a 3" resurfacing/mill and fill, Type 2 curb and gutter on Cedar Brook Lane at a total cost of \$243,863. Pavement Technology, Inc. completed 5,059 s.y. of reclamite for a total cost of \$6,071. Township contracted with Smith Paving to do a 3" resurfacing/mill and fill, Type 3 curb and gutter with 2" drops at drive approaches in Galloway Estates at a total cost of \$355,863. Pavement Technology, Inc. completed 7,760 s.y. of reclamite for a total cost of \$9,312. Township contracted with Smith Paving to do a 1.5" asphalt overlay, Type 3 curb and gutter with 2" drops at drive approaches in Green Creek at a total cost of \$298,477. Pavement Technology, Inc. completed 5,513 s.y. of reclamite for a total cost of \$6,616. Township contracted with 7L Construction to do a 3" resurfacing/mill and fill on Matthes Avenue and Briar Drive at a total cost of \$82,903. Pavement Technology, Inc. completed 6,013 s.y. of reclamite for a total cost of \$7,216. Township will be installing sidewalks from King Avenue to Strickfaden Park, and Marshall Avenue to Stonyridge Drive, 9,271 s.f. with flashing crosswalk beacon light at Bell Avenue and Columbus Avenue at a total estimate cost of \$148,268. Township contracted with Strawser Construction, Inc. to complete crack seal (37,570 s.y.) on various roads throughout the township at a total cost of \$21,791.

**Vermilion Township:** Township contracted with Cowboy Rocks to repair approximately 40' of damaged 12" concrete storm sewer on Colonial Court for a total cost of \$3,000. Township contracted with Quality One Tree/Full Bucket Excavating to do land clearing and excavation in a ditch located on Holiday Drive at a total cost of \$18,600. Township contracted with Buck Pavement Restoration to apply liquid road to Colonial Court, Hickory Drive and Sassafrass Drive East at a total cost of \$24,930. Township employees placed berm stone on various roads throughout the township using 80 ton of #411 at a total material cost of \$1,028. Township employees placed 18 tons of #8 stone on top of Bailey Road West at a total material cost of \$324. Township employees used 47 tons of #9 stone and 500 gallons of emulsion for Dura Patcher throughout the township at a total material cost of \$2,301. Township employees installed a catch basin on Thompson Road at a total cost of \$600. Township employees applied 2,200# of Seal Master crack sealer on various roads throughout the township at a

total material cost of \$1,800. Township employees enclosed 120' of open ditch on Cemetery Road at homeowners expense. Erie Blacktop, Inc. completed resurfacing .60 miles (9,956 s.y.) in Vineyards of Vermilion Subdivision at a total estimated cost of \$131,945.

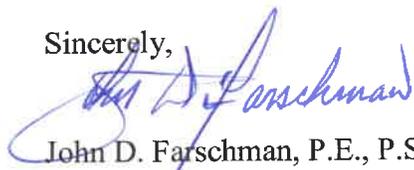
The total numbers of drainage systems currently under ditch maintenance is 125 plus the 3 joint county ditches maintained by Sandusky County remaining at a total of 128.

IN SUMMARY:

The county engineer's staff and field supervision strive to achieve high, yet achievable goals. We continue to be faced with financial challenges and personnel shortages to bring our county system of highways up to the desired industry standard by asphalt resurfacing on a ten year cycle. With our new MVGT revenues, there is still far insufficient funding to accomplish this. Our bridge replacement program as well as the most cost effective methodology of maintaining our roadways continues to be severely compromised solely by the commissioner's power to remove yet more of our revenues to give to townships whom already have road tax levies in place. This, in spite of the general funds overflowing with excessive balance sheet(s) preserving their own to give away in the form of bonuses, which continues to take its toll on our working capital. Monies that would more responsibly be used to pay down county debt. We remain focused and committed to maximizing our accomplishments within those financial resources that are appropriated by our county commissioners; (resources over which the Erie County Engineer has absolutely no control) while serving our citizens professionally and responsibly. As a direct result of the commissioners actions, and in spite of our concerted efforts to provide our citizens with the greatest amount of safety through the preparation of a durable system of roadways at a cost effective expense, after decades of improvements, our roadways and drainage systems as we have previously known and enjoyed them, are now in an ongoing state of disrepair over which the Erie County Engineers have virtually, no control.

This summarizes the major contributions of the Erie County Engineers to the citizens of Erie County that were accomplished during 2023.

**SURVEY & FIELD WORK**

**WORKING SHORT HANDED** Mike Farrell, our surveyor, with help wherever he could get it to serve our needs rendered the following services:

County and Township Roads, Bridge and Culvert work, Miscellaneous Drainage Projects and Property Locations for Easements. *The Scope of Field Work includes but is not necessarily limited to: (1) Determination of centerline control (set monument boxes), (2) Topography, (3) Cross Sections, (4) Drainage and further; construction layout consisting of: (1) Slope staking (2) Layout of structures (3) Setting grades and (4) Final quantity determinations.* Also now collecting data countywide using GPS instrument.

Also, County and Township Road Resurfacing Projects and determination of total quantities completed.

Assist in Traffic Studies, pavement marking and signage.

Survey Office Work for the general public which consists of: *(1) Researching Lot splits (2) Verification of closure of all Subdivision Plats and lots (3) Research the Right-Of-Way (4) and assist the Public when, and as necessary.*

The Survey Department researches records for centerline; records fieldwork notes; and writes all easements for the County Engineer or other County Officials.

## **NOTES ON YEAR 2023 TRAFFIC STUDIES**

- Completed a total of 13 traffic studies.
- Conducted 1 study to change an existing speed limit on a county road. This study is in progress.
- Conducted a total of 12 traffic volume studies. Many of these volume studies were to determine traffic volumes for various proposed township and county projects, especially projects with ODOT Township Stimulus, Ohio Public Works or CDBG funding. Traffic counts allow appropriate design criteria, such as signal timing, lane and shoulder width, and pavement thickness, to be accurately determined and designed.

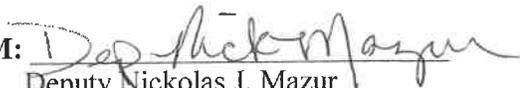

ERIE COUNTY DITCH MAINTENANCE  
ANNUAL REPORT

This was another productive year for improvements made to Erie County Maintenance ditches, tile systems and subdivisions under the care of this department.

Accomplishments include:

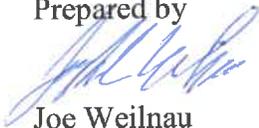
- 5,336 linear feet of ditch reshaped, realigned, dipped and/or had debris removed to allow for normal flow, as well as to provide adequate freeboard for tile outlets.
- 101,930 linear feet of brush trimming and clearing.
- 7 rock structures along with several tiles and culverts were repaired
- 256 feet of new tile installed and 3,094 linear feet of various size tiles were jet-vaced or videoed.
- 125,528 linear feet of ditch was sprayed along with detention areas and tile outlets
- 20 basins were repaired and two new basins installed

The mowing program started in early summer continuing thru late fall as weather permitted. Twenty-Two ditches, with the combined length of over 19 miles were completed. This mowing program allows for a more economical application of herbicides by not wasting the solution on last year's dead vegetation, while still allowing for wildlife nesting and habitat utilization.

Ditch Maintenance has 53 subdivisions with 48 detention basins that need regular spraying and or mowing maintenance. Twenty Seven of the detention basins were again targeted this year to address persistent and hard to control noxious weeds such as cattail and phragmite along with broadleaf and woody vegetation. This was accomplished with a rigorous spray and mowing program of over 284,000 sq. ft. of combined area. The end result is a stand of grass which keeps the banks protected from erosion and manageable for continued maintenance.

This department manages and maintains 128 projects that include 3 joint county projects, which have a combined maintenance base of over \$16 million dollars.

<b>R.B.</b>	RETENTION BASIN (USED TO CONTROL RUN-OFF AND SILT.)
