Family Responsibilities:

- The family will maintain a home learning environment that supports academic progress. All district property will be used for educational purposes only.
- The family will take steps to ensure Sto-Rox School District property is being used exclusively by the student who has been issued the computer and related equipment.
- The family will designate a primary contact for the purposes of communicating with Sto-Rox teachers and the Virtual Viking Academy facilitator.
- The family will monitor student performance and ensure the student contacts the District for academic support and to report technical difficulties when progress appears to be stalled.
- The family will refrain from attempting to make repairs to district property and will report technology problems to the Sto-Rox School District.
- Students will abide by all district policies and adhere to Sto-Rox School District student code of conduct while attending school events and participating in their online studies.
- The student is responsible for the safekeeping and return of equipment. Students in grades 7-12 will meet or exceed all expectations for minimum login time, which amounts to approximately 40 minutes per class per day. Students in grades K-6 are expected to log on for daily livestream lessons that coincide with a typical school day.

District Responsibilities:

- The Sto-Rox School District will provide a contact person within the district to address any/all concerns within a reasonable amount of time.
- The district will provide a computer and necessary related equipment (if needed) to facilitate online studies for students who are enrolled full time in the Virtual Viking Academy. *Note: The computer and other equipment issued remain the property of the Sto-Rox School District. Computers and equipment are collected at the end of each school year in order to perform basic maintenance and updates and are redistributed at the start of the new school year. The student and parent/guardian are responsible for any lost or damaged equipment.*
- The Sto-Rox Virtual Viking Cyber Academy students who participate in district-sponsored, extra-curricular activities are subject to academic and attendance monitoring as per district, WPIAL, and PIAA policies and procedures.

Students who choose to enroll in Sto-Rox Virtual Vikings Academy will be issued a letter grade for each course completed upon verification of academic performance. Students are responsible for meeting all district graduation requirements. All students are expected to follow the Acceptable Use of Computer policy of the Sto-Rox School District.
