

## **ANTWERP SCHOOLS WELLNESS & RECREATION CENTER and FIELD HOUSE FOB ENTRANCE AFTER SCHOOL HOURS FACILITY INFORMATION, GUIDELINES, RULES & REGULATIONS**

**FACILITY MISSION/VISION:** Antwerp Local Schools mission and vision for the Wellness & Recreation Center and Field House is to provide and ensure a safe and enjoyable environment for community members to enhance their wellness through exercise and social interaction.

### **USE OF THE WELLNESS & RECREATION CENTER and FIELD HOUSE:**

- \* In order to access entry into the Center and Field House, you will need a KEY FOB. The KEY FOB will allow you access to the main recreation area, restrooms, fitness/classroom and weight room.
- \*The main recreation area features a half court basketball area, a volleyball court, and two pickle ball courts. The fitness/classroom is a space dedicated for stretching, yoga, aerobic exercise, and exercise instruction. The Field House has numerous weight-lifting equipment. Any school equipment utilized in the Center or Field House must be returned to its original location prior to your departure. Likewise, make sure the exit door closes completely and is in locked mode.
- \* KEY FOB access to the Wellness & Recreation Center for community members, will be available during the following time frames: (Monday – Friday) at 2:45 p.m. and concludes at 9:00 p.m. Weekend access is 9:00 a.m. – 9:00 p.m. Access entry will be through the door entrance scanner located on the north facing side of the Center building.
- \* KEY FOB access for the Field House is on the west side of the Field House. The Field House is available to community members (Monday – Friday) 6:00 a.m. to 8:00 a.m. and 6:30 p.m. to 9:00 p.m., (Saturday) 12:00 p.m. to 9:00 p.m., and (Sunday) 9:00 a.m. to 9:00 p.m.
- \* Mr. Drew Altimus is the Director of the Center and Field House. Contact Mr. Altimus to schedule a time frame that you would like to utilize the recreation area, fitness/classroom, or Field House weight room for yourself or small group of individuals. You may also view availability of the Center and Field House on our school website. Click on the Calendars/Schedules dropdown and select Wellness & Recreation Center Calendar.
- \* Please note that school athletic and extra-curricular teams/groups have precedence with use of the Center and Field House and may override your reserved time.
- \*Mr. Altimus can be contacted by email at: (altimus\_d@antwerpschools.org) or text (419) 506-0496. Do not call or leave a voice message.

### **KEY FOB:**

- \* Community members may purchase from the school Central Office, an initial KEY FOB for a cost of 10 dollars. If your KEY FOB is lost or stolen, please contact the school's Central Office (419)258-5421 ext. 2300
- \* A replacement KEY FOB may be purchased for 5 dollars.

### **KEY FOB ELIGIBILITY:**

- \* Must be at least 18 yrs. old and graduated from high school.
- \* Show proof you reside in the school district (Examples: Driver license, utility bill)

### **FOB RULES/REGULATIONS:**

\* At no time can you give your KEY FOB to someone else for use. If this rule is violated, your KEY FOB will be shut off and no longer available for use.

\* At no time shall you allow other individuals to enter the Center or Field House unless permission has been given to you by Mr. Drew Altimus – Wellness & Recreation Center/Field House Director. Individuals entering the Center or Field House under your supervision must be enrolled as a student at Antwerp Local Schools; no exceptions. Likewise, you are responsible for any and all actions of the student under your supervision. Additionally, you shall provide written notice to the Superintendent of any accident resulting in bodily injury or damage to District property caused by a person accessing the Center or Field House under your supervision. The notice must be provided within twenty-four (24) hours of the accident. Such written notice must include the name and address of the person involved in the accident, name and address of any witnesses, and details regarding the time, place, circumstances and nature of the injury or property damage.

\* Anyone entering the Center's recreation area must have with them a change of shoes. Individuals are requested to change your shoes once you enter the recreation area. The shoes you removed can be placed in Cubbies that are located in the locker room/storage area immediately to your right as you enter the Center.

### **PROHIBITED ITEMS/CONDUCT/CLOTHING/ACTIVITIES:**

\* Alcohol, drugs, smoking, vaping, and weapons of any nature are not permitted on school grounds or buildings associated with the Antwerp Local School District.

\* Photography, videotaping, filming, or audio recording is not permitted in the Center and Field House unless permission is granted from Mr. Drew Altimus – Wellness & Recreation Center/Field House Director.

\* Food and beverages are not permitted in the Center and Field House; however, water is permitted.

\* Individuals desiring to bring equipment, (including exercise equipment) into the Center or Field House must have permission from Mr. Drew Altimus – Wellness & Recreation Center/Field House Director.

\* Individuals utilizing the center are required to wear a shirt, t-shirt, or sports top on their upper body and shorts, sweatpants or leggings on their waist.

\* Individual conduct such as abusive, offensive, insulting, demeaning language, profanity, lewd conduct or any conduct that harasses or is bothersome to others in the Center or Field House is not permitted.

*Violation of the previously stated "prohibited items, conduct/clothing/activities" will result in your KEY FOB being shut off.*

### **FOR YOUR PROTECTION AND THE MAINTENANCE OF SAFE FACILITIES, THE WELLNESS & RECREATION CENTER and FIELD HOUSE HAVE NUMEROUS SECURITY CAMERAS AND OTHER SECURITY SURVEILLANCE FEATURES IN PLACE TO MONITOR ACTIVITIES.**

## RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

In consideration of participating in the Antwerp Local Schools KEY FOB use for the Wellness & Recreation Center and Field House, I hereby agree to release and discharge from liability arising from negligence the Antwerp Local School District Board of Education, administrators, teachers, custodians, or entities acting for them (hereinafter collectively referred to as "Release's"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agree as follows:

1. I acknowledge that the Center and Field House will be unstaffed during after school hours and weekends. Activities that I may be involved with come with unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death, and injuries as a result of falls, equipment failure, or contact with other participants. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
2. I expressly accept and assume all of the risks inherent in accessing the Center and Field House or that might have been caused by the negligence of the Release's. My access to the Center and Field House, and my participation in the activities therein are purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or mental conditions, then I will immediately discontinue participation.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Release's from any and all claims, demands, or causes of action which are in any way connected with my access to the Center and Field House and/or my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Release's or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while accessing the Center and Field House or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in activities associated with the Center and Field House, or else I am willing to assume - and bear the cost of - all risks that may be created, directly or indirectly, by any such condition.
5. In the event that I file a lawsuit, I agree to do so in the state of Ohio where the Release's Center and Field House is located, and I further agree that the substantive law of Ohio shall apply.
6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
7. I acknowledge that any injury/paralysis or permanent disability, death or property damage occurring due to an unauthorized area of the Wellness & Recreation Center and Field House during after-school or weekend hours is at my own risk and liability.

I have read, and thoroughly understand the AFTER-SCHOOL HOURS FACILITY INFORMATION, GUIDELINES, RULES & REGULATIONS and agree to be bound by its terms.
