II. PUBLIC PARTICIPATION (po0169.1)

A. The Board of Education recognizes the value to school governance of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest. The Board offers public participation to members of the public in accordance with the procedures below. The Board applies these procedures to all speakers, and does not discriminate based on the identity of the speaker, content of the speech, or viewpoint of the speaker.

The Board is also committed to conducting its meetings in a productive and efficient manner that assures that the regular agenda of the Board is completed in a reasonable period of time, honors the voluntary nature of the Board's time and using that time efficiently, and allows for a fair and adequate opportunity for input to be considered. Consequently, public participation at Board meetings will be governed by the following principle.

In order to permit the fair and orderly expression of such comment, the Board shall provide a period for public participation at every regular meeting of the Board and publish rules to govern such participation in Board meetings.

The presiding officer of each Board meeting at which public participation is permitted shall administer the rules of the Board for its conduct.

The presiding officer shall be guided by the following rules:

- 1. Public participation shall be permitted as indicated on the order of business.
- 2. Anyone having a legitimate interest in the actions of the Board may participate during the public portion of a meeting.
- 3. Attendees must register their intention to participate in the public portion of the meeting upon their arrival at the meeting.
- **4.** Participants must be recognized by the presiding officer and will be requested to preface their comments by an announcement of their name, address, and group affiliation, if and when appropriate.
- 5. Each statement made by a participant shall be limited to five (5) minutes duration, unless extended by the presiding officer.
- **6.** The presiding officer may:
 - a. prohibit public comments that are frivolous, repetitive, and/or harassing;
 - **b.** interrupt, warn, or terminate a participant's statement when the statement is too lengthy, abusive, off-topic, obscene, or irrelevant;
 - **c.** request any individual to leave the meeting when that person does not observe reasonable decorum or is disruptive to the conduct of the meeting;
 - **d.** request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
 - e. call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action;

f. waive these rules with the approval of the Board when necessary for the protection of privacy or the administration of the Board's business.

The portion of the meeting during which the participation of the public is invited shall be limited to thirty (30) minutes, unless extended by a vote of the Board.

V. Approve a resolution urging the Ohio General Assembly to waive all state mandated standardized testing requirements for the 2020-2021 school year, request a waiver from state mandated testing from the US

Department of education, and declare the Tuscarawas Valley Local School Board's support for House Bills 67 and 40, which would fulfill both requests and declare an emergency.

WHEREAS, it is the statutory duty of the Tuscarawas Valley Local School District to deliver the educational programs and services to the school children of the Tuscarawas Valley Local School District, and

WHEREAS, the members of the Board are elected by the Tuscarawas Valley Local school community to ensure that students are healthy, safe, engaged, supported, and challenged, and

WHEREAS, the elected board of education is responsible to the community including taxpayers, parents and other patrons, as well as the state, and

WHEREAS, the state of Ohio requires annual, statewide standardized testing in accordance with federal mandates, and

WHEREAS, the COVID-19 pandemic has created instructional challenges and forced educators to quickly adapt to new practices during the 2020-2021 school year, and

WHEREAS, the administration of standardized tests may create additional, unnecessary health risks to students and District staff, and

WHEREAS, the State of Ohio waived standardized testing last spring when learning was disrupted for less than half of the academic year, and

WHEREAS, the Tuscarawas Valley Local School District and its educators already perform formative testing on every District student – tests that during a pandemic are far more helpful and accurate in addressing student need, and

WHEREAS, the results of the statewide, mandated standardized testing won't be known until after the school year is ended and will be of no help to District students or the District's need to potentially address any disrupted learning opportunities District students may face, and

WHEREAS, the education professionals in the Tuscarawas Valley Local School District are best able to assess those COVID-19 related needs better than an out-of-state standardized test developer, and

WHEREAS, the Tuscarawas Valley Local School District and its educators are committed to ensuring every District student is able to succeed, and

WHEREAS, the worst introduction to in-person instruction this Board can imagine would be a battery of biased standardized tests given to students that will be useless in determining what those students need to learn academically, and

NOW, THEREFORE, BE IT RESOLVED BY THE TUSCARAWAS VALLEY LOCAL SCHOOL DISTRICT BOARD OF EDUCATION THAT:

SECTION ONE:

The Board of Education urges the State of Ohio to only administer the spring 2021 statewide standardized assessments required by federal law. And the Board fully supports House Bills 67 and 40, which would provide greater flexibility in administering the assessments.

SECTION TWO:

The Tuscarawas Valley Local School Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this Resolution were taken in open meetings of this Board and any deliberations of this Board and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

The Board declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of the Tuscarawas Valley Local School District. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to the Board, it shall take effect and be in force immediately upon its passage.

VI. Approve a resolution recommending amendment to the Ohio School Boards Association 2021 Legislative Platform:

WHEREAS, the Tuscarawas Valley School District is a member of the Ohio School Boards Association (OSBA), and

WHEREAS, the OSBA advocates through a "legislative platform" that is reviewed and amended each year by OSBA member districts, and

WHEREAS, the current legislative platform contains language related to Vouchers, and

WHEREAS Tuscarawas Valley School District and its local taxpayers could be harmed by EdChoice Voucher Program, and

WHEREAS, public school districts operate under a biased test-based accountability system that is inherently flawed and one which private and non-public schools who accept public money are not held to, and

WHEREAS, research studies have shown a correlation between low scores on standardized tests and poverty, and

WHEREAS, in FY 2021, Ohio's Public Schools will have nearly \$150 million hijacked from their state funding to be redirected to private non-public schools based on these test scores, and

WHEREAS, teachers and administrators at private non-public schools are not held to the same professional licensing requirements as they are in Ohio's public schools, and

WHEREAS, non-public schools are continuing go after more public school students yearly

WHEREAS, public school districts are audited by the State of Ohio annually, and are subject to Ohio's Public Records laws.

NOW THEREFORE, BE IT RESOLVED, on March 8, 2021, The Tuscarawas Valley Local School District's School Board of Education recommends the following language be added to the legislative platform under the "Voucher" plank:

OSBA supports legislation that:

- Requires all vouchers to be funded in a way that does not deduct from or diminish funding to public school districts
- Places a cap on the amount of money a district can lose to vouchers
