What is financial aid?

 Financial aid consists of funds provided to students and families to help pay for postsecondary educational expenses



What is Cost of attendance (COA)?







- Tuition and fees
- Room and board
- Books and supplies
- Transportation
- Miscellaneous personal expenses





What is Expected family contribution (EFC)?


 Measurement of student's and family's ability to pay postsecondary educational expenses





What is financial Need?








Free application for federal Student aid (FAFSA)

- May be filed at any time during an academic year, but no earlier than October 1st prior to the academic year for which the student requests aid
- For the 2023-24 academic year, the FAFSA may be filed beginning October 1, 2022 and will ask for the 2021 tax return information
- Each school has their own priority aid deadline
- Wright State's FAFSA priority deadline is February 1, 2023 for the 2023-2024 Aid year

What are the qualifications to receive federal student aid?

- U.S. citizen/national or eligible non-citizen
- High School diploma or equivalent
- Eligible degree/certificate program in college/career school
- Student with a valid Social Security number
- Satisfactory academic progress in college/career school
 - Info about eligibility: StudentAid.gov/eligibility



IRS Data Retrieval Tool (DRT)

- Allows for certain tax return information to be transferred from the IRS database
- Participation is voluntary and student chooses whether to transfer data to FAFSA on the Web
- IRS will authenticate taxpayer's identity
- If tax record is found, IRS transfers information to populate the FAFSA
- Reduces documents requested by financial aid office

Institutional Scholarships

- Find out from the office of Financial Aid at your school how to apply for scholarships, and the submission deadline.
- Inquire when awards will be made and how students will be notified of awards

• External (Private) Scholarships

- Scholarships offered by donors/foundations outside the university
- Can be offered Employers, communities, or other organizations
- Can be based in anything
- Smaller Scholarships add up

How much federal student aid can I get?

Maximum amounts for the major programs for a dependent student in 2022-23:

- Federal Pell Grant: \$6,895 for those with 0 EFC
- Federal Work-Study: depends on funds available at school
- Direct Subsidized and Unsubsidized Loans:
 - \$5,500 total for a freshman (0-29 earned credit hours)
 - \$6,500 total for a sophomore (30-59 earned credit hours)
 - \$7,500 total for a junior or senior (earned over 60 credit hours)
- Direct PLUS Loan (for parents): COA minus other aid received
- Financial aid cannot exceed the COA (Cost of Attendance)



Why do I need my child's permission to view financial award packages when I'm the one paying for my child's education?



 To comply with the Family Educational Rights and Privacy Act of 1974 (FERPA), students age 18 and older must give written consent to release their education records to outside parties, including their parents. These records include, but are not limited to, financial aid, scholarships and fellowships, and student account/billing information.

What is SAP? Your Financial Aid Depends on It!

 To maintain satisfactory academic progress (SAP), undergraduate students and graduate/doctoral students must meet certain requirements. All students enrolled in courses will be evaluated for SAP. This includes courses taken while not receiving Title IV financial aid.

Satisfactory Academic Progress (SAP)

Cumulative G.P.A. (2.0)

Completion Rate (67% Rule)

Maximum Timeframe (150% Rule)

* If you plan to attend the school through which you have earned CCP credits, your SAP has already begun

Take Flight Program at Wright State University for Fall Admissions

- Take Flight is for you if you are:
 - Enrolling directly from high school to attend Wright State's Dayton campus for the 2023 Fall Semester;
 - An Ohio resident and have a cumulative high school GPA of 3.2 or higher; and
 - Have an Expected Family Contribution (EFC) of 2,000 or less as indicated by the Free Application for Federal Student Aid (FAFSA).
- In addition to covering the cost of up to 18 hours of undergraduate tuition, the program also provides the following benefits:
 - Fee waiver for you and one family member for summer orientation
 - Dedicated success team, including academic advisor, success coach, and career consultant
 - On-campus employment through the Federal Work-Study Program
 - (Note: You must have unmet need and satisfy federal requirements for Work-Study eligibility).
