2021-22 TUITION AGREEMENT

Payment Options

The Tuition Agreement indicating a payment plan must be signed when a student registers for classes. Tuition payments may be made by cash, check, money order, automatic monthly payment through FACTS, or credit card. 2.5% fee for credit card transactions.

_____ **One Payment Plan** – Tuition Payment is due on or before **August 2, 2021**. \$100 dollar discount applies only to a student who receives no scholarship or financial assistance and pays full payment.

_____ **Two Payment Plan** – The first semester payment is due on or before **August 2, 2021**. The second semester payment is due on or before **January 3, 2021**. A \$50 annual administrative fee applies.

_____ **Friends and Family Credit Union** – A tuition loan program to help parents who want their children to attend private high schools. You will be able to pay a full year’s tuition at the beginning of the school year and earn discount of up to \$125 to offset interest. For more information www.friendsandfamilycu.com.

_____ **Monthly Payment Plan** – Eleven monthly automatic payments from a checking or savings account beginning in August 2021 and ending in June 2022. A \$150 administrative fee applies.

_____ **EdChoice Traditional or Expansion (Low Income) Scholarship*** – new/or previously qualified, will reapply at <http://education.ohio.gov/> (signed agreement required, deposit is waived)

*Ed Choice Scholarship eligibility is determined by the State of Ohio. If the Student does not qualify, then tuition will be charged.

Our family understands that our relationship with Stark County Catholic High Schools is contractual and contingent upon our adherence to the philosophy, policies, and procedures of the School. I have received a copy of the School’s Family/Parent Handbook that contains the School’s philosophy, policies, and procedures and I acknowledge and agree that adherence to the School’s philosophy, policies, and procedures is an express condition for admission and continued enrollment by the student. I understand that this agreement is for the 2021 - 2022 school year, and continued attendance at Stark County Catholic High Schools will be determined annually.

It is understood that a parent’s obligation to pay the charges for tuition, student fee, and other school fees for the full academic year is unconditional and that no portion of such charges so paid or outstanding will be refunded or canceled notwithstanding the subsequent absence, withdrawal, or dismissal from Stark County Catholic High Schools of the student. It is understood that enrollment may be canceled in writing, without penalty (except the registration fee) prior to August 2, 2021. If enrollment is canceled after August 2, 2021, parents or guardians financially responsible for the student are obligated to pay the full tuition, student fee, and any other fee incurred for services for the full academic year. In extreme circumstances, the school may, in its sole discretion, adjust the parent’s or guardian’s liability for tuition and fees for the full academic year.

ADDITIONAL TERMS AND CONDITIONS

1. I agree that all payments owed under this Agreement will be paid by the due date corresponding to the payment method(s) selected above. I understand and agree that, regardless of what payment option is selected, I am personally responsible for the payments and for ensuring that the tuition and fees are paid in full. Should I be late in making any payment, I understand that the following process will be followed:

- a. I, and the other parents/guardians (if they are not me), will be notified of any payment not received.
 - b. A \$50 late fee will be assessed. (on FACTS Tuition)
 - c. I will be given 30 calendar days to bring the account to current status or meet with school administration to have an adjusted payment agreement approved (not a guarantee and must be in writing and signed by the school president).
 - d. If, within 30 calendar days, the account is not brought to current status, or an adjusted payment agreement is not agreed upon and approved by school administration, the student enrollment will cease at the end of the current quarter, and the school may immediately take any action available and consistent with applicable law in order to collect unpaid tuition owed by me/us including but not limited to limiting access to field trips and extra-curricular activities, withholding academic transcripts, referral to a collection agency, and/or the institution of a civil lawsuit to recover the unpaid balance.
2. Any family with an unpaid Tuition and/or Fees balance for the current School Year will not be allowed to register for the following School Year and School records, diplomas or transcripts will not be released until the current year's Tuition and fees are paid, unless special arrangements have been made in writing and signed by School principal or School president.
 3. Prepaid Tuition will only be refunded in full if written notice of cancellation is received by the School before the first day that classes for the School year are scheduled to start. The Registration Fee and Technology Fee are non-refundable.
 4. Once the School year begins, Tuition refunds are made on a quarterly basis. Should a Student attend School during any portion of a quarter (one day or more), the full tuition amount for that quarter is owed and no portion of that quarter's tuition will be refunded except at the discretion of the President or Principal.
 5. The Student(s) and Student's parents/guardians agree that they and their child(ren)/ward(s) will abide by the policies and guidelines as stated in the School handbook.
 6. Returned checks: If two checks are returned for insufficient funds, the school will no longer accept personal checks and you will be required to pay in cash, with a certified check from a local bank, or through FACTS or another electronic payment provider at the school's discretion.
 7. I understand that the School will not reserve a place for my child(ren) for the upcoming school year until after I have returned a completed and signed Tuition Agreement, plus the registration fee, and, if applicable, an agreement has been created in FACTS for semi-annual or monthly tuition payments. I further understand that my child's/children's eligibility for enrollment is conditioned upon (1) his/her successful completion of the current School Year; (2) full payment of all Tuition and fees owed for the current and/or prior School Years; and (3) acceptance by the school. I understand that the School reserves the right to deny admission or enrollment for any lawful reason.
