Bidder hereby agrees to commence work under this contract on or before a date to be specified in a written Notice to Proceed and to fully complete the project in the number of calendar days stated below. Bidder understands that the Owner reserves the right to reject any or all bids and to waive any informality in the bidding. The Bidder agrees that this proposal shall be good and may not be withdrawn for a period of sixty (60) days after the scheduled closing time for receipt of bids.

The contract is to be performed within NINETY (90) consecutive calendar days from date of the contract or Notice to Proceed subject to allowances made for delays due to shortages of materials or energy resources subject to proof by documentation and also delays due to strikes or other delays beyond the control of the contractor, all reasons for delays documented and verified. For each day of delay in completion of the work, the contractor shall be liable for, and pay to the Owner, liquidated damages in the amount of ONE HUNDRED DOLLARS (\$100.00) per consecutive calendar day.
