## Gifted Identification and Services Summary

### 2023-2024

#### IDENTIFICATION

- The state of Ohio sets the criteria for gifted identification.
- Districts are required to use the test instruments approved by the Ohio Department of Education for gifted identification.
- Students may be tested twice per year in each area the state recognizes for gifted identification. Grade level screening counts as one test opportunity.
- Districts are required to screen all students for gifted identification in superior cognitive ability, reading, math, and creative thinking ability at least once in grades K-2 and at least once in grades 3-6. In U.A.C.S, students in grades 2 & 4 are screened in the fall. All other students are tested by referral (via small group testing in grades 2-5 in spring or with a school psychologist).
- Information about the gifted identification process in the visual and performing arts will be provided via school newsletters beginning October 2023.

## GIFTED SERVICES

- In Ohio, school districts report the criteria for their gifted services to the Ohio Department of Education for approval. Districts are not required to provide any gifted services, but if they do, they must apply the criteria for them consistently and fairly.
- Students who qualify for gifted services after the start of the school year will begin those services at the start of the following school year.
- For the purpose of qualifying for gifted services for the next school year, requests for testing must be received by March 1 of the current school year.

9-12	Science of Robotics*	Ohio gifted identification in superior cognitive ability, creative thinking ability, <b>or</b> science

*\*These high school courses are open to all students regardless of gifted identification. However, they are gifted service settings for students who meet the criteria.*
