ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a Safe Return to In-Person Instruction and Continuity of Services Plan, hereinafter referred to as a Health and Safety Plan.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

Facilities

The District will continue to follow the guidance outlined by the CDC, PDE, DOH and the ACHD. Custodial and maintenance staff will be trained in best practices and methods for sanitation, disinfecting, cleanliness, and ventilation protocols. Filters will continue to be replaced as defined in the preventative maintenance schedule. Increasing the circulation of outdoor air will be encouraged when doing so does not pose a safety risk.

This work will be supervised by the Director of Facilities and reports will be made to the District's Pandemic Team. All products will meet OSHA and CDC requirements. The Director of Facilities will monitor the custodians and maintenance work and review documents to ensure that frequent cleaning is taking place.

Physical Distancing

As of August 11, 2022, the CDC is no longer recommending physical distancing or cohorting.

Monitoring Health

Parents and families will be encouraged to keep ill children at home until the symptoms improve. Families are expected to perform a symptom screening BEFORE sending their children to school. Symptoms associated with COVID-19, include fever, headache, chills, body aches, congestion, shortness of breath, fatigue, loss of taste or smell, and diarrhea. The District will continue to track cases within the District and will post the numbers on the (COVID-19 page) of the District website. The 2022-2023 Health and Safety Plan will also be posted to the website and any updates will be approved by the Board.

The District will also follow mandates released by PDE, DOH, ACHD, and/or the CDC.

2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

The District converted to one to one devices in the 2020-2021 school year. The school families were surveyed to confirm that families had reliable access to the Internet. The families that did not have reliable Internet we assigned a mobile hotspot to be used to complete schoolwork only. In addition, Canvas, a learning management system was purchased for the professional and support staff to use to deliver the curriculum. The District will ensure continuity of services by monitoring the data collected through various assessments such as DIBELS, NWEA/MAPS, PASS, and teacher observation. If the District is required to close due to the number of positive cases, the students and staff will transition the next school day to online learning

through Canvas. Students will also be able to access food services as outlined by state and federal regulations.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.
