Call to order:

The meeting was called to order by Officer Bogdanski.

Old Business:

- Return to building for students starting February 1st.
- Contact borough to ensure crossing guards return February 1st.
- Multi-directional cameras added to the 2nd and 3nd floor of Annex; old cameras repurposed.
- All construction has been completed at the HS.
 - o All concrete work has been completed.
 - No more tripping hazards on walkways or lots.
 - o Bollards added to the posts in front of the auditorium doors.
 - o Main HS entrance has reopened for staff/student access to the building.
- Multiple entrance points to the buildings will continue to be used to allow for social distancing.
- Elroy: replace middle section of railing on steps on East Francis side of building.
 - o Removed as a safety concern, rusted.
 - Not required according to code.
 - Will not be replaced.
- HS teacher with desk positioned in the center of the room creating tripping hazards caused by wires on the floor.
- Play practice in the HS auditorium; masks must be worn by participants.
 - o Option of presenting the play virtually.
- Ofc. Bogdanski tasked with creating a district Threat Assessment Team.
 - o Mandated by the state.
 - o Combining of Student Assistance Program and Safe to Safe Program.
 - o Selection and training of members beginning February 1st.

Corrective Actions Taken:

- Students returned one ay then FID days issued. Smooth transition back to in-person.
- Crossing guards have returned and will be added to the call-out list for delays and cancellations.
- New Cameras installed and linked.
- Construction complete. Meetings started for the summer projects at the high school (windows/doors).
- Multiple entrances still being used for entrance to the building.
- Elroy railing will not be replaced.
- Dir. George working with maintenance to resolve wire issues in classrooms.
- Dr. Olexa advised to update play staff on COVID protocols.
- First portion of training completed. Second portion being completed in March.

- Crossing guards; Brentwood Chief of Police advised there were issues keeping the positions staffed. Chief requested a meeting with Dr. Burch and Ofc. Bogdanski to discuss.
 - o Continue the conversation with borough regarding crossing guard availability
- Issues with lens on the new camera. Security 101 will resolve.
 - o Lens has been repaired
- Ice forming on gutters at Elroy
 - o Maintenance is monitoring the situation to ensure that the area is safe and no one will get hurt
