implemented a reduction in force and laid off one (1) teacher; and

WHEREAS, based upon a vacancy created as a result of subsequent personnel changes and the needs of the District for the 2021-2022 school year, the Superintendent has recommended the recall of one (1) teacher; and,

WHEREAS, pursuant to Article V, Section E of the Negotiated Agreement between the Board of Education and the Association, the Board of Education wishes to recall one (1) teacher for the 2021-2022 school year.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Mapleton Local School District, Ashland County, Ohio, that:

Section 1. The Board of Education hereby authorizes the recall of one (1) classroom teacher to a vacant position for which he is certified/licensed and/or qualified, as permitted under Article V, Section E of the Negotiated Agreement between the Board of Education and the Association.

Section 2. Based upon the provisions of Article V, Section E of the Negotiated Agreement between the Board of Education and the Association, and the certification/licensure and/or qualifications of the affected teacher, Brian Baker is recalled to active employment effective August 1, 2021. The Treasurer is directed to give the employee written notice of this action on behalf of the Board of Education.

Section 3. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in these formal actions were in meetings open to the public and in compliance with the legal requirements, including Section 121.22 of the Ohio Revised Code and Section 12 of H.B. 197 and any amendments thereto.
