- Preorder is REQUIRED each day

- The preorder form will be available each day beginning the evening of Sunday, March 15th
- Additional meals available for students that drop in, but availability will be limited

- Meals will be free for all children ages 1-18

- Breakfast for the next morning will be given out with lunch

- Adult meals are not available for purchase

Voicemail Meal Order Instructions

- Dial 438-7673
- When the message begins enter extension 5466
- State student's first and last name (only 1 name necessary per household)
- State quantity of meals needed (all children in your household age 1-18 are eligible for free meals even if they do not attend UCASD)
- State the pick-up location number which you will be using:
 - #1 Union City MS/HS Main Gym Entrance Lobby open from 11AM-1PM
 - #2 Troyer Brothers (10200 Route 6) available from 11:10-11:25AM
 - #3 McNulty's Fruit Stand (15250 Route 8) available from 11:35-11:50AM
 - #4 Wilcox Garage (7810 Route 97) available from 12-12:15PM
 - #5 Bloomfield Fire Hall (22978 Shreve Ridge Rd.) available from 11:15-11:35AM
 - #6 Duane Jackson Insurance (24870 Route 8) available from 11:45AM-12PM
 - #7 Sill Farm (9660 Concord Rd.) available from 12:10-12:25PM
- You must call between the hours of 2PM-8PM the day prior to meal service
- Remember to call each day (Sunday-Thursday) prior to the day that you need meals provided
