- All fire alarm systems including fire alarm pulls and fire alarm strobe lights will be removed by Dickson County Schools and will not be included in the bid for the surplus portables.
- Utilities to be disconnected by Dickson County Schools.
- All city-county-state permits for removal will be the responsibility of the successful bidder.
- Ramp and decks are optional.
- Masonry piers may be included.
- Damage to school property will be the responsibility of the successful bidder.
